- Current .5% school capital outlay surtax is **extended** and expires 12/31/2028.
- Current 1% small county surtax remains in effect and expires upon repeal.
- Collier 1% Total Surtax Rate**
- **New** 1% local government infrastructure surtax begins 1/1/2019 and expires 12/31/2025.
- Hillsborough 2.5% Total Surtax Rate**
- **New** 1% charter county and regional transportation system surtax begins 1/1/2019 and expires 12/31/2048.
- **New** .5% school capital outlay surtax begins 1/1/2019 and expires 12/31/2028.
- Current .5% indigent health care surtax remains in effect and expires upon repeal.
- Current .5% local government infrastructure surtax remains in effect and expires 11/30/2026.
- Lee .5% Total Surtax Rate**
- **New** .5% school capital outlay surtax begins 1/1/2019 and expires 12/31/2028.
- Martin .5% Total Surtax Rate**
- **New** .5% school capital outlay surtax begins 1/1/2019 and expires 12/31/2025.
- Okaloosa .5% Total Surtax Rate**
- **New** .5% local government infrastructure surtax begins 1/1/2019 and expires 12/31/2028.
