SALES AND USE TAX

Sales and Use Tax collections were \$2,613.6m in October, and above the October 2019 collections by \$77.2m (3%). Collections for Sales Tax include Local Option Sales Tax and 2.6% Gross Receipts. These receipts are from the perspective of department collections and do not reflect collections of other state entities.

CORPORATE INCOME TAX

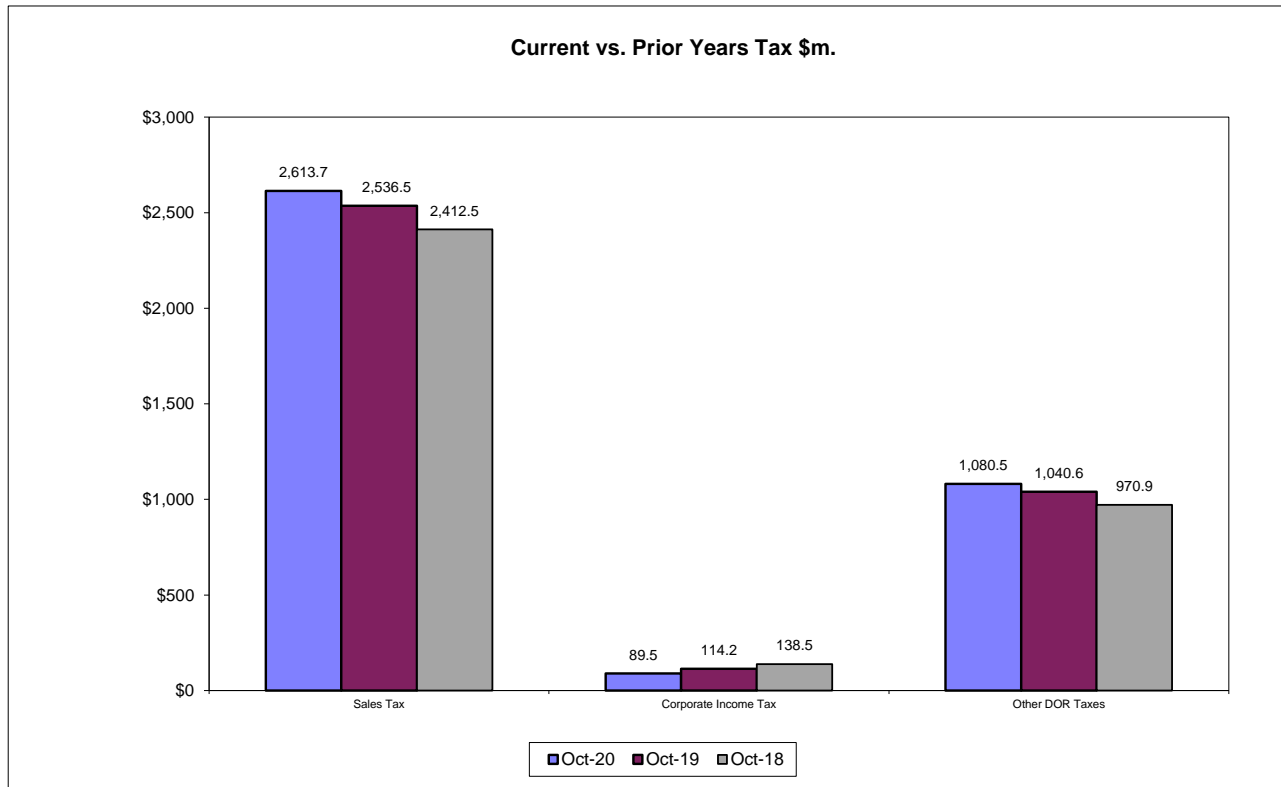
CIT collections of \$89.5m in October 2020 were under the October 2019 collections by \$24.6m (-21.6%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

DOCUMENTARY STAMP TAX

Documentary Stamp Tax collections of \$294.1m were above the October 2019 collections by \$29.5m (11.1%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

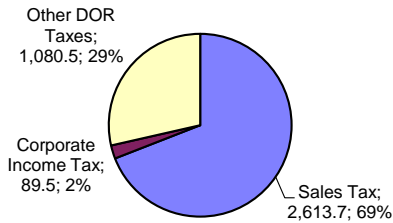

OTHER DOR TAXES...

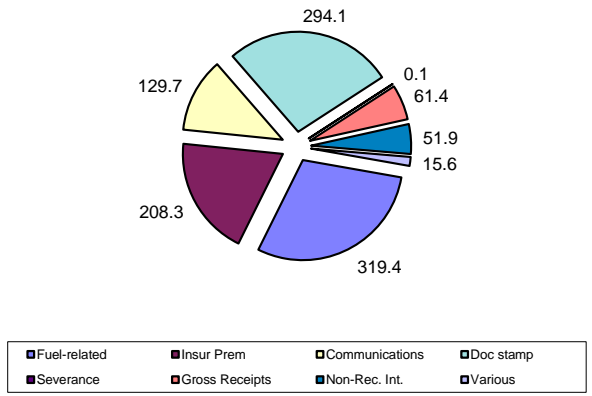
...excluding Sales Tax and Corporate Income Tax, other taxes contributed \$1080.5m to DOR tax collections in October 2020. The October 2020 collections were \$40m (3.8%) above the same month previous year's collections. The Doc Stamp Collections in October 2020 were \$294.1m. Compared to October 2019 collections on Doc Stamp Taxes, the October 2020 collections were \$29.5m (11.1%) above.

The October 2020 collections of the Communications Services Tax compared to October 2019 collections were \$0.2m (-0.2%) below. The collections of Insurance Premium Tax in October were 213.1m. Compared to October 2019 collections on Insurance Premium Taxes, the October 2020 collections were \$4.7m (2.3%) above. The collections of Fuel-related Taxes & Fees in October were above the prior year by \$14.3m (4.7%). The non-recurring Intangible Tax collections were \$5.2m (11.2%) above the prior year.

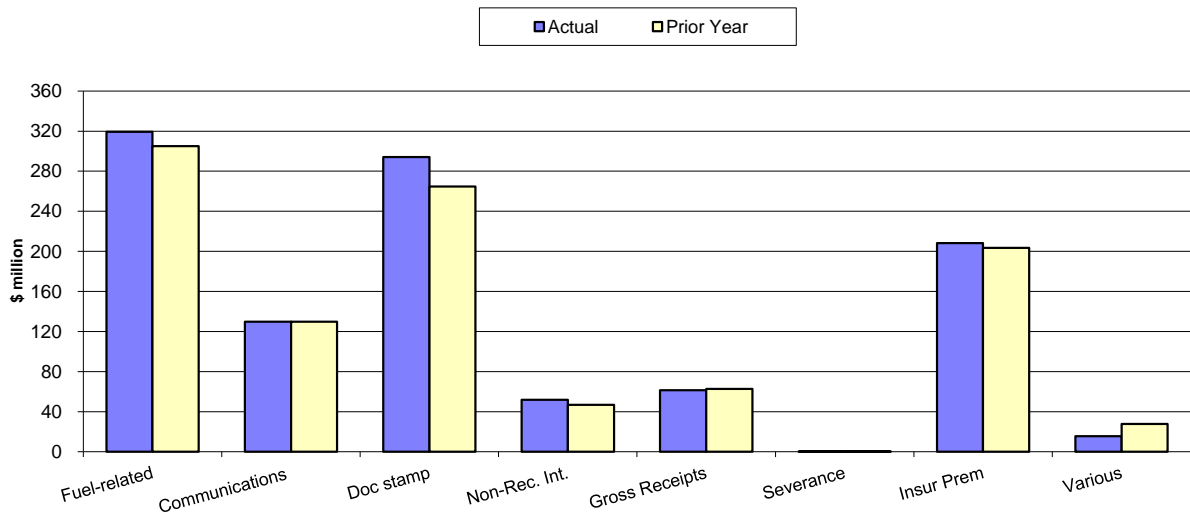
**Sales, Corporate & Other DOR Taxes \$m.

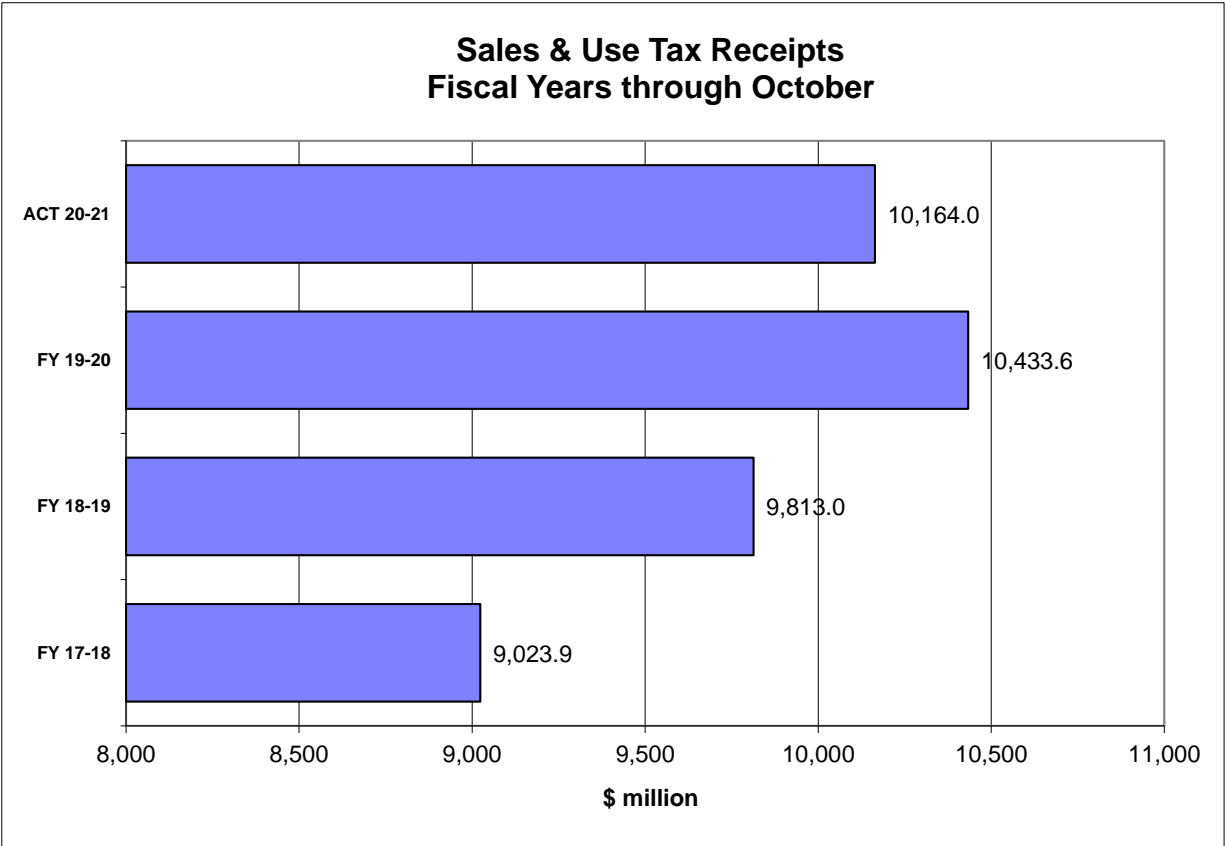
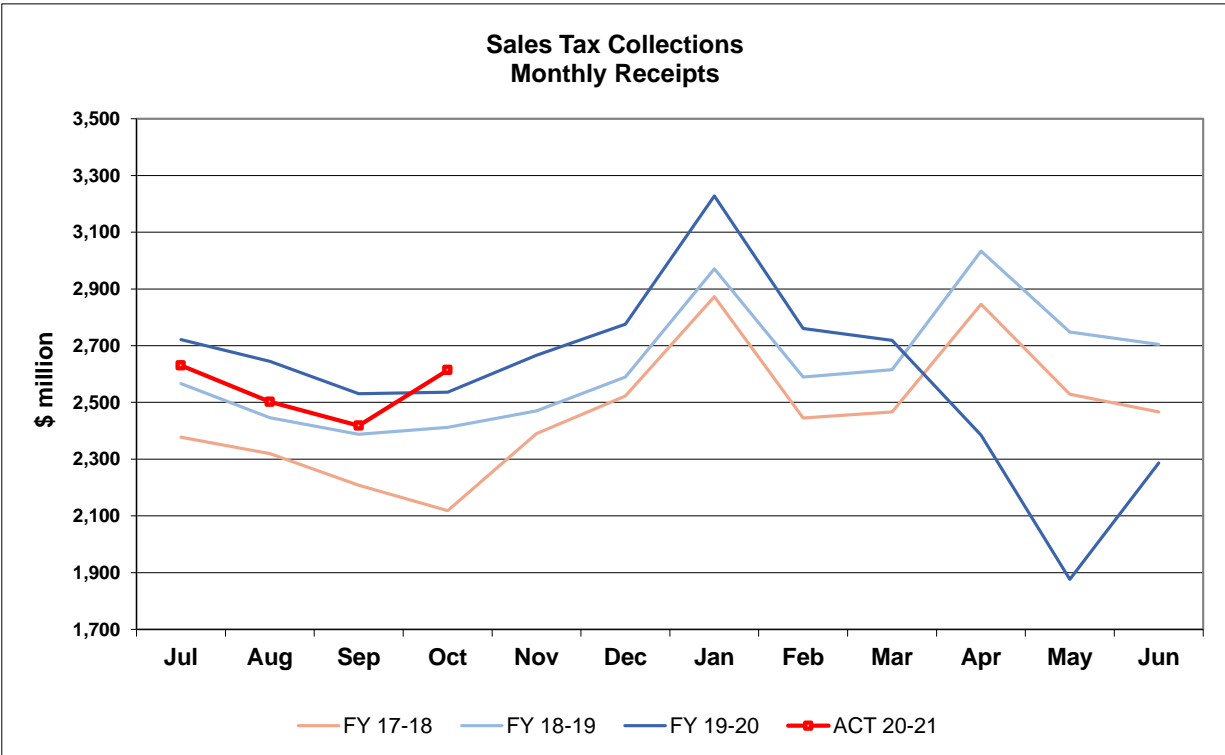

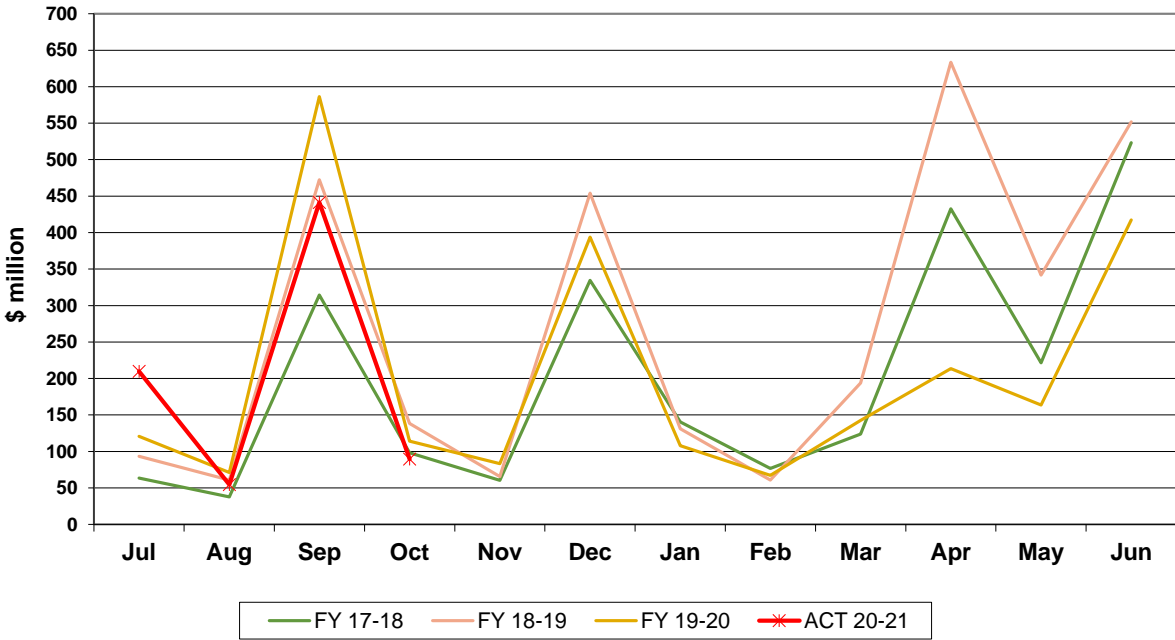


HISTORICAL COMPARISON GRAPHS

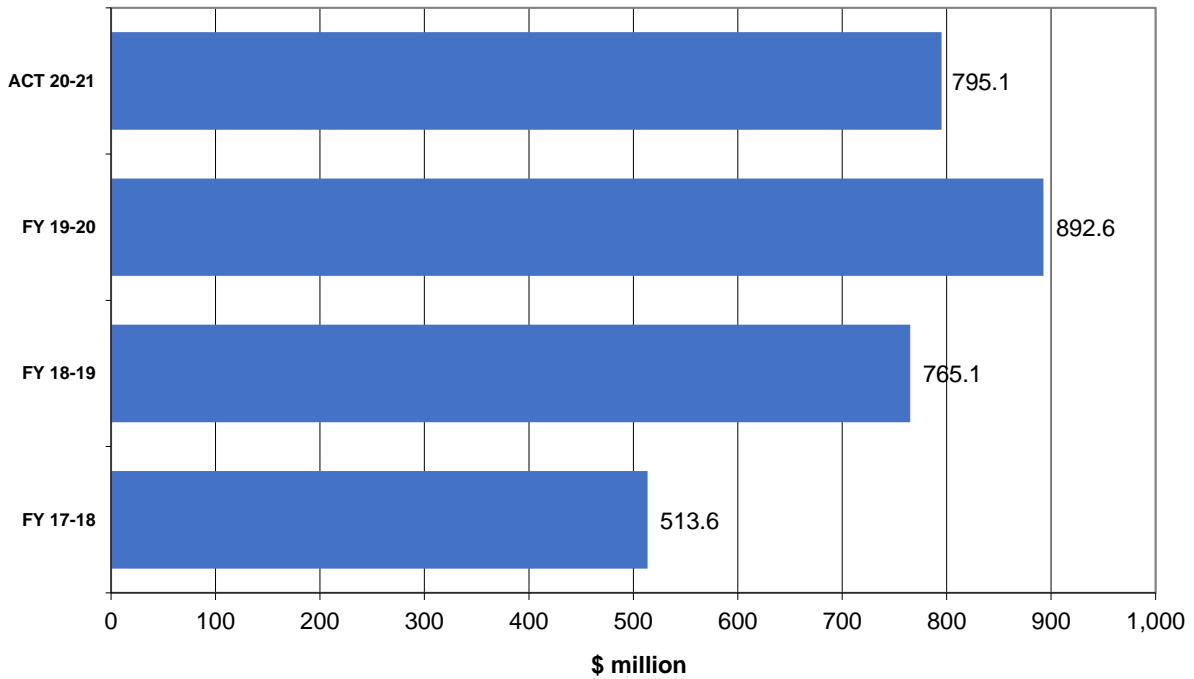

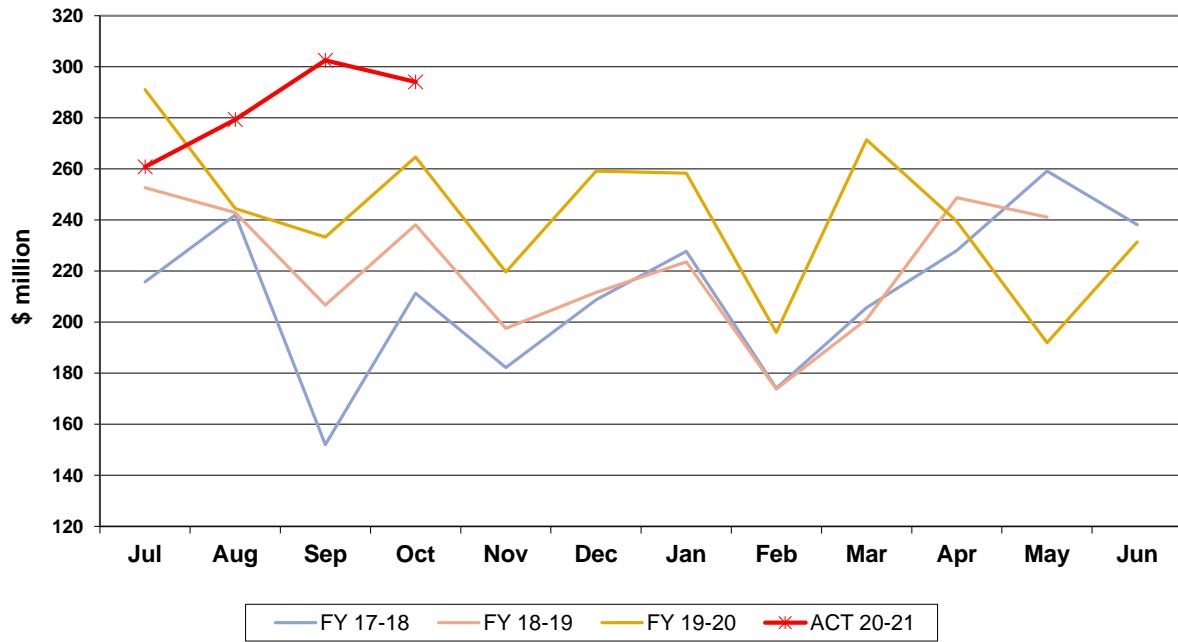
Corporate Tax Collections Monthly Receipts



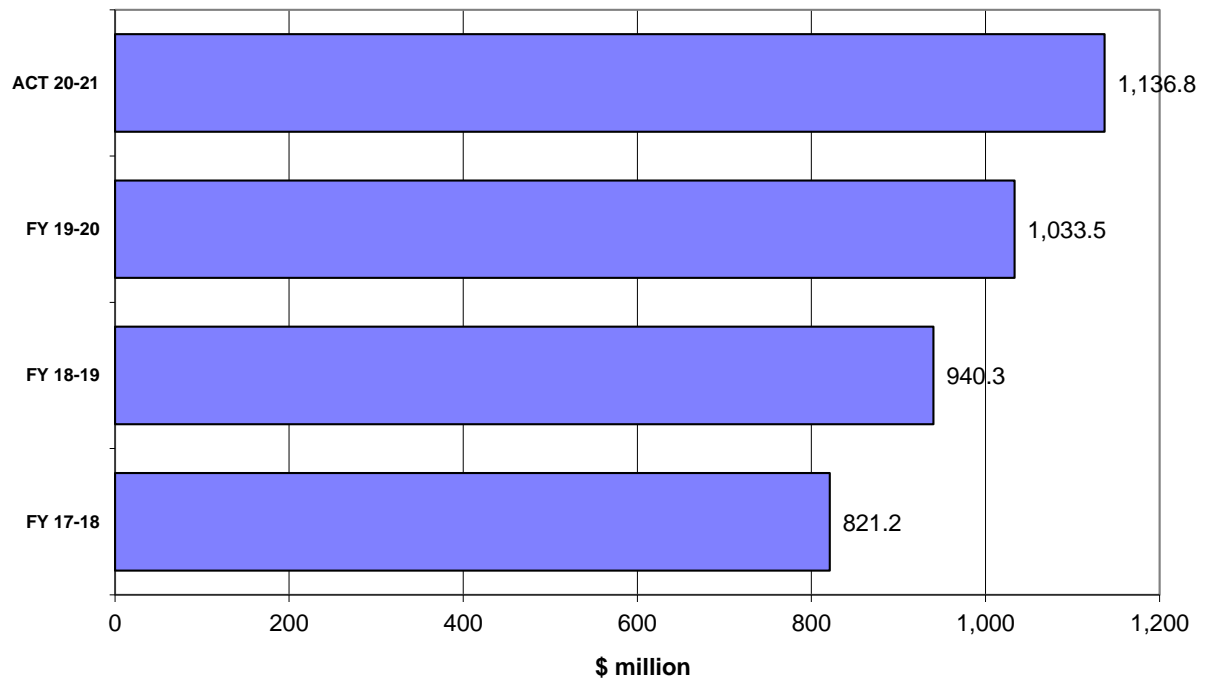
Corporate Income Tax Receipts Fiscal Years through October



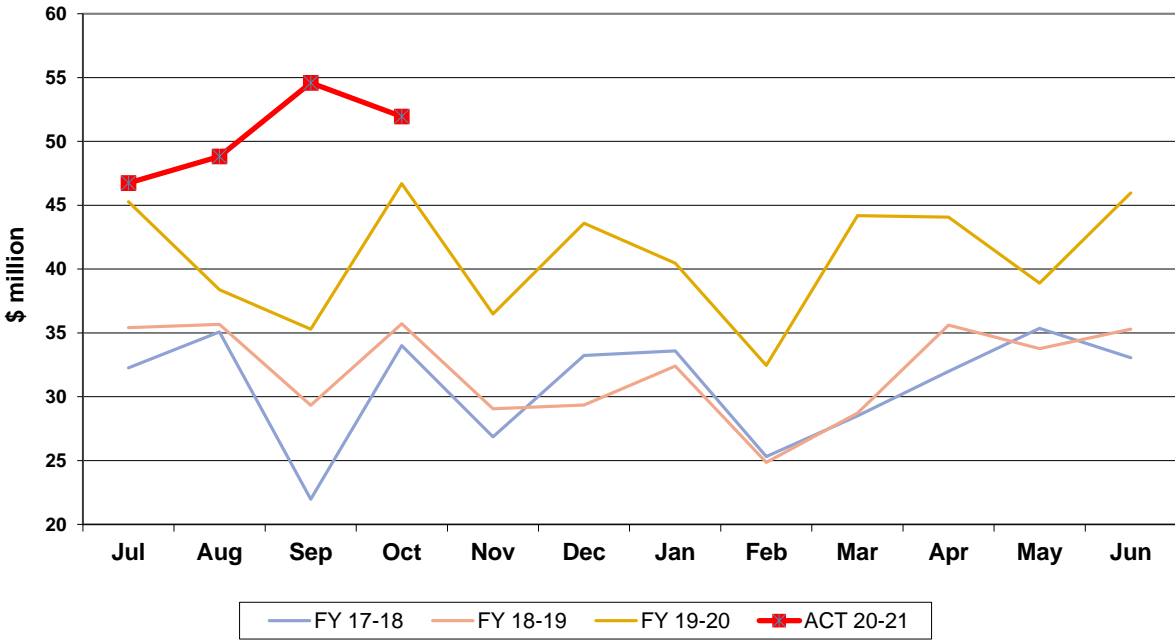
Doc Stamps Tax Collections Monthly Receipts



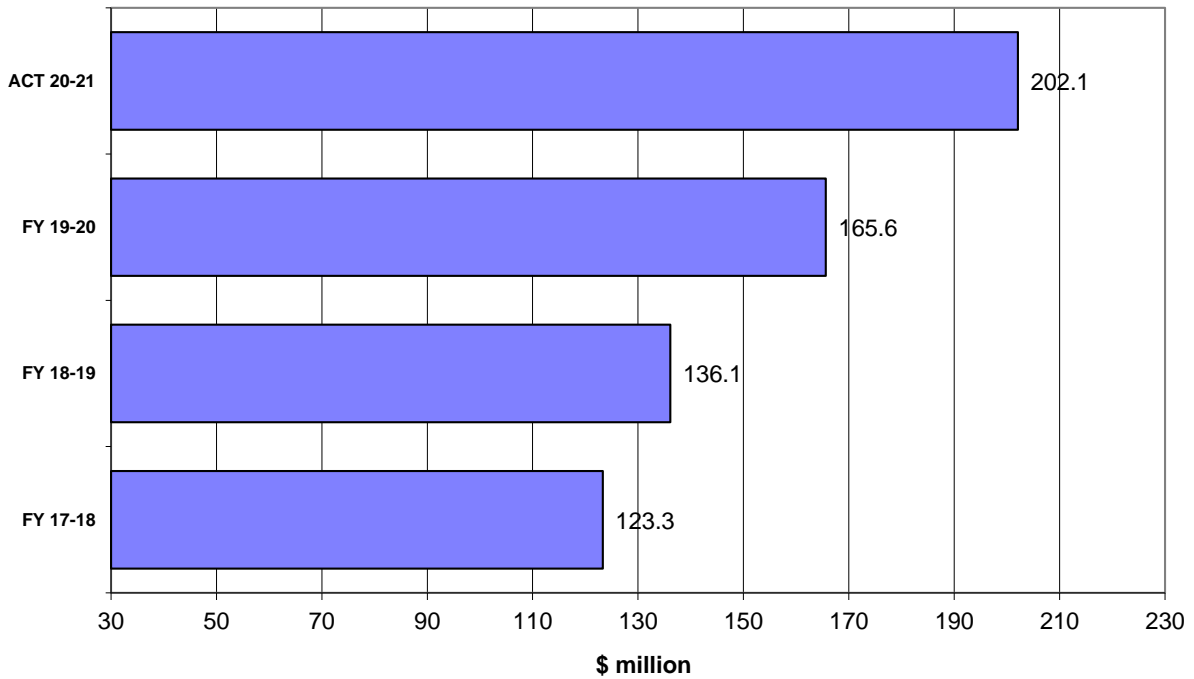
Doc Stamps Tax Receipts Fiscal Years through October



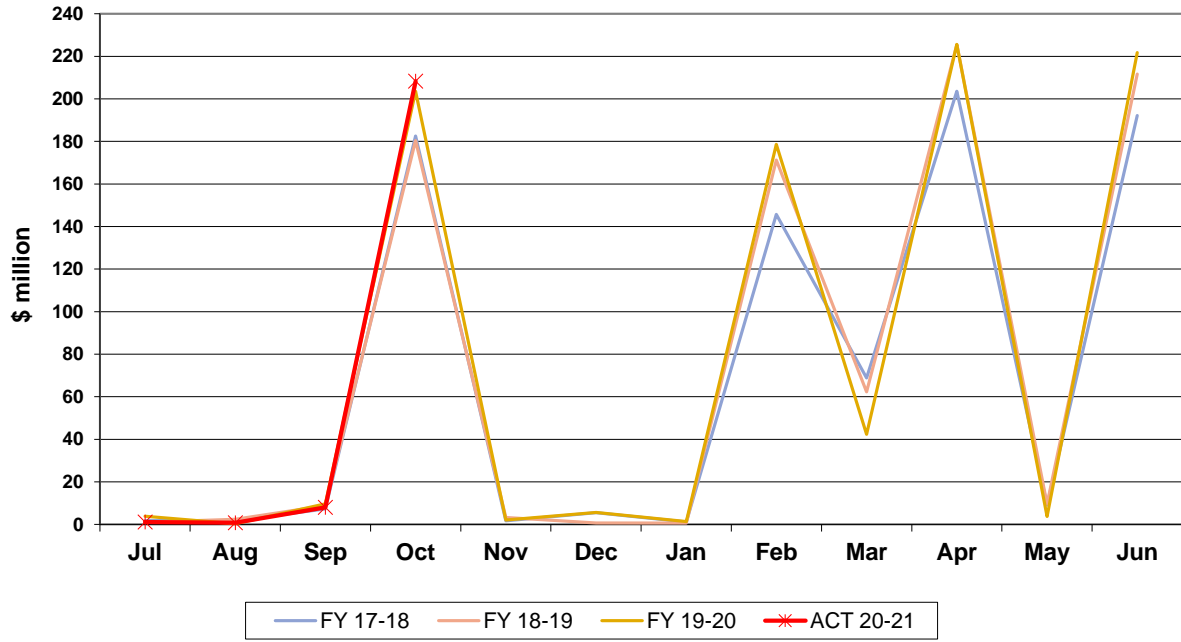
Non-Recurring Intangible Tax Collections Monthly Receipts



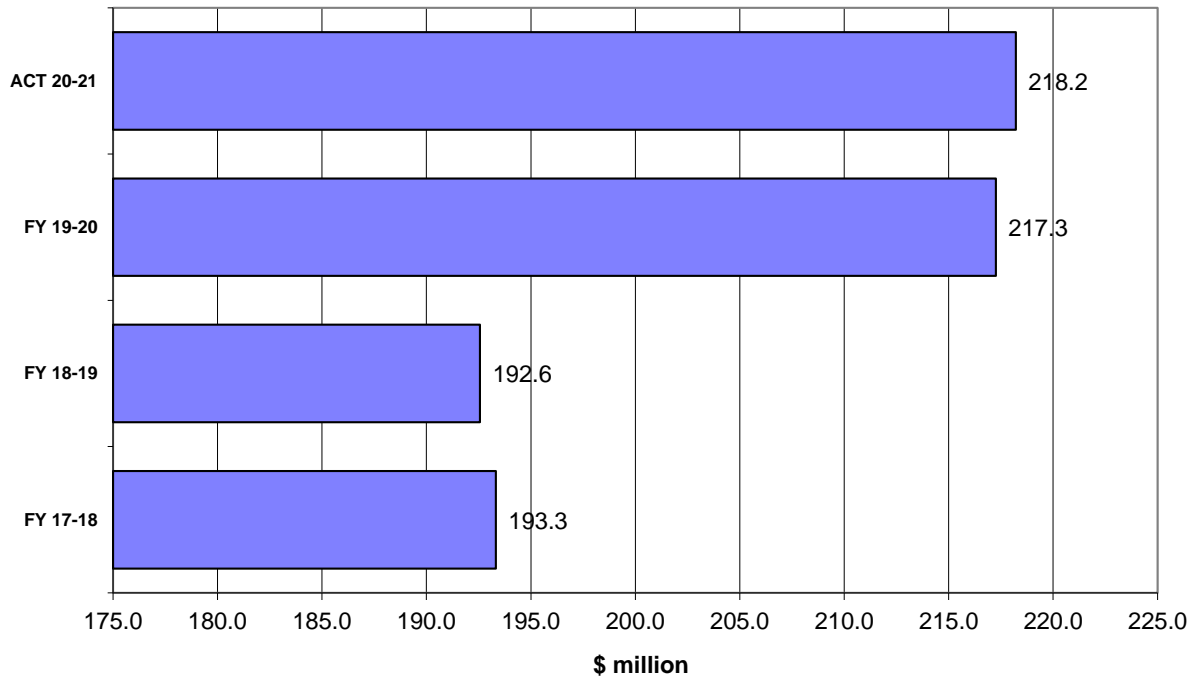
Non-Recurring Intangible Tax Receipts Fiscal Years through October



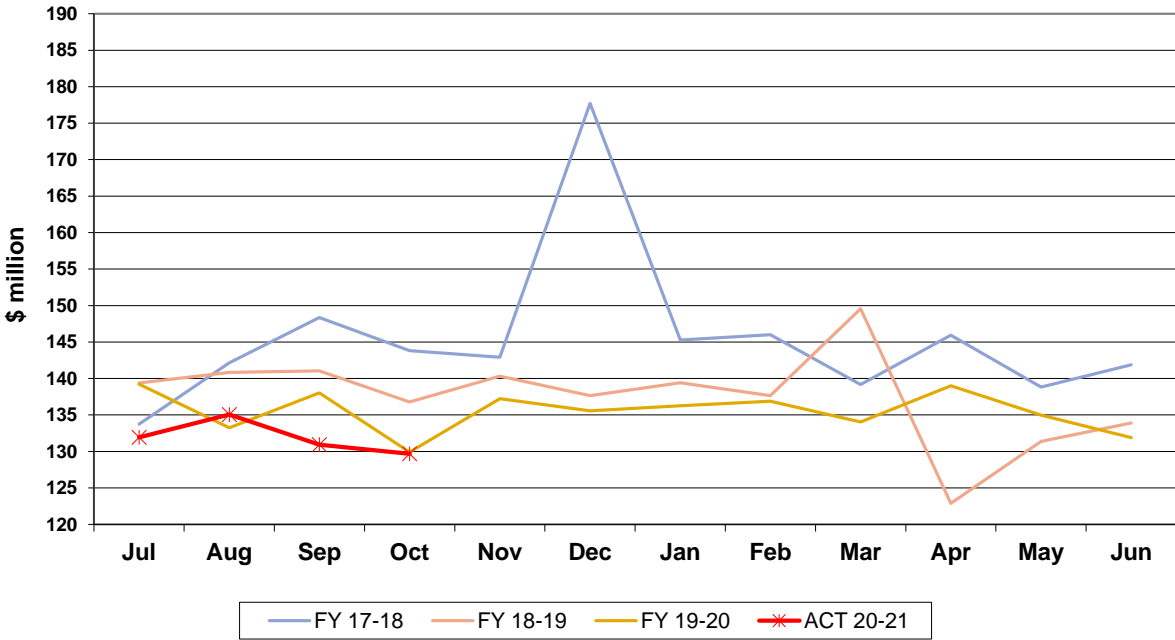
Insurance Premium Tax Collections Monthly Receipts



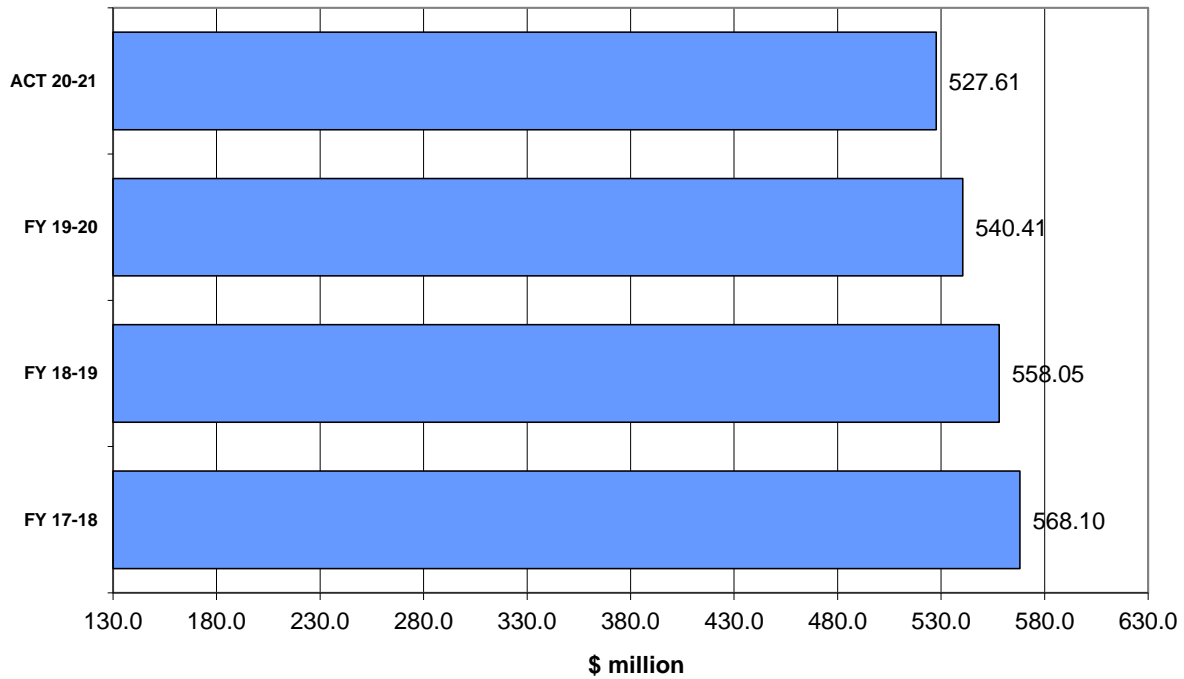
Insurance Premium Tax Receipts Fiscal Years through October



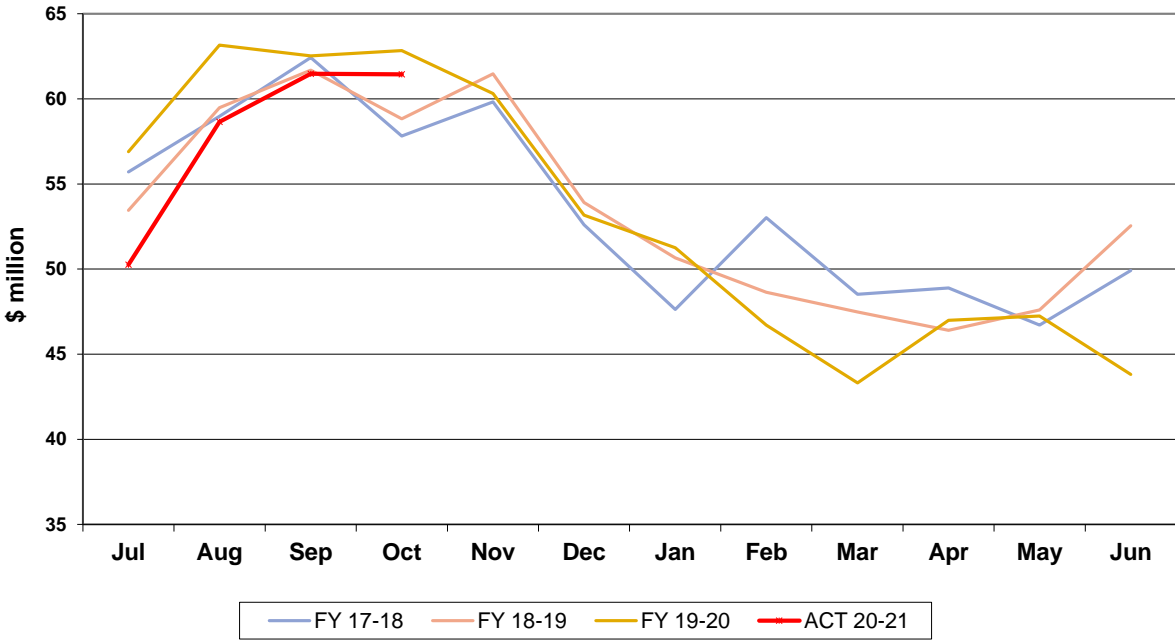
Communication Services Tax Collections Monthly Receipts
