Changes in Local Communications Services Tax Rates Effective January 1, 2020

Effective January 1, 2020, local communications services tax (CST) rates will change for three Florida jurisdictions. These local tax rate changes are pursuant to ordinances adopted by the governing authorities of the jurisdictions.

The following jurisdictions will have rate changes due to local ordinances adopted by the governing authority of the county or municipality. The total local CST rate includes: (1) the local rate imposed under the CST statute; and (2) any county discretionary sales surtax (DSS) conversion rate that may be imposed under the sales and use tax statute.

Palm Shores (Brevard County)	5.22%	5.82%
Gulf Breeze (Santa Rosa County)	5.22%	5.82%
Marco Island (Collier County)	2.10%	2.80%

The local rates listed in the chart above are effective for all bills issued on or after January 1, 2020, regardless of the date the service is rendered or transacted. These rates will stay in effect until further notice by the Department.
