This document lists county discretionary sales surtax rates for calendar year 2015. It is each dealer's responsibility to verify, collect, and remit the correct amount of surtax on taxable sales, services, use, or deliveries made within each county.

Specific 2015 county surtax rate changes are listed on the back of this notice. Counties that are shaded in grey have more than one surtax.

Each county that has a surtax levy that is new, revised, or extended is indicated in bold. Any county that has a surtax that expires in 2015 is also in bold and has an ← beside the expiration date.

Effective January 1, 2015, the following counties have surtax rate changes:

- Brevard County** **.5% Total Surtax Rate**
➤ **New** .5% School surtax begins 1/1/2015 and expires 12/31/2020
- Charlotte County** **1% Total Surtax Rate**
➤ 1% Infrastructure surtax scheduled to expire 12/31/2014 is extended and will expire 12/31/2020
- DeSoto County** **1.5% Total Surtax Rate**
➤ **New** .5% Indigent Care surtax begins 1/1/2015 and expires 12/31/2035
➤ Current 1% surtax remains in effect and has no expiration date
- Escambia County** **1.5% Total Surtax Rate**
➤ 1% Infrastructure surtax scheduled to expire 12/31/2017 is extended and will expire 12/31/2028
➤ .5% School surtax scheduled to expire 12/31/2017 is extended and will expire 12/31/2027
- Hernando County** **0% Total Surtax Rate**
➤ .5% School surtax expired 12/31/2014
- Highlands County** **1% Total Surtax Rate**
➤ 1% Infrastructure surtax scheduled to expire 12/31/2018 is extended and will expire 12/31/2033
- Leon County** **1.5% Total Surtax Rate**
➤ 1% Infrastructure surtax scheduled to expire 12/31/2019 is extended and will expire 12/31/2039
➤ Current .5% surtax remains in effect and expires 12/31/2027
- Monroe County** **1.5% Total Surtax Rate**
➤ .5% School surtax scheduled to expire 12/31/2015 is extended and will expire 12/31/2025
➤ Current 1% surtax remains in effect and expires 12/31/2033
- Orange County** **.5% Total Surtax Rate**
➤ .5% School surtax scheduled to expire 12/31/2015 is extended and will expire 12/31/2025
- Seminole County** **1% Total Surtax Rate**
➤ **New** 1% Infrastructure surtax begins 1/1/2015 and expires 12/31/2024
- Volusia County** **.5% Total Surtax Rate**
➤ .5% School surtax scheduled to expire 12/31/2016 is extended and will expire 12/31/2031

Discretionary sales surtax collections are distributed to local governments in Florida. Dealers should collect surtax on taxable sales at the rate imposed in the county where the merchandise or service is delivered. Surtax also applies to the rental of real property and transient rentals and is collected at the county surtax rate where the property is located. For motor vehicle and mobile home sales, use the surtax rate of the county identified as the residence address of the purchaser on the registration or title document.

Surtax applies to only the first \$5,000 of the sales amount on any item of tangible personal property. The \$5,000 surtax limitation does not apply to rentals or leases of real property or sales of: services, admissions, service warranties, or prepaid calling arrangements.
