1 Evaluator professional designations include at 2 least two years of experience with a Florida 3 property appraiser's or tax collector's office or 4 the Florida Department of Revenue, at least 120 5 hours of approved education, and current employment with a Florida county property 6 7 appraiser's or tax collector's office or the Florida Department of Revenue. The Certified 8 9 Florida Appraiser designation is reserved for the 10 county official.

11 The qualifications for the Certified 12 Cadastralists of Florida include at least two 13 years of experience with a Florida property 14 appraiser's office or the Florida Department of 15 Revenue, at least 150 hours of approved education, 16 and current employment with a Florida property 17 appraiser's office or the Florida Department of 18 Revenue.
