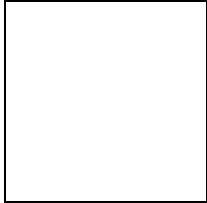

- DR-501A, Statement of Gross Income
- DR-501T, Designation of Ownership Shares of Abandoned Homestead
