**SALES AND USE TAX**

Sales and Use Tax collections were \$3,550.6m in April, and above the April 2020 collections by \$1165.7m (48.9%). Collections for Sales Tax include Local Option Sales Tax and 2.6% Gross Receipts. These receipts are from the perspective of department collections and do not reflect collections of other state entities.

**CORPORATE INCOME TAX**

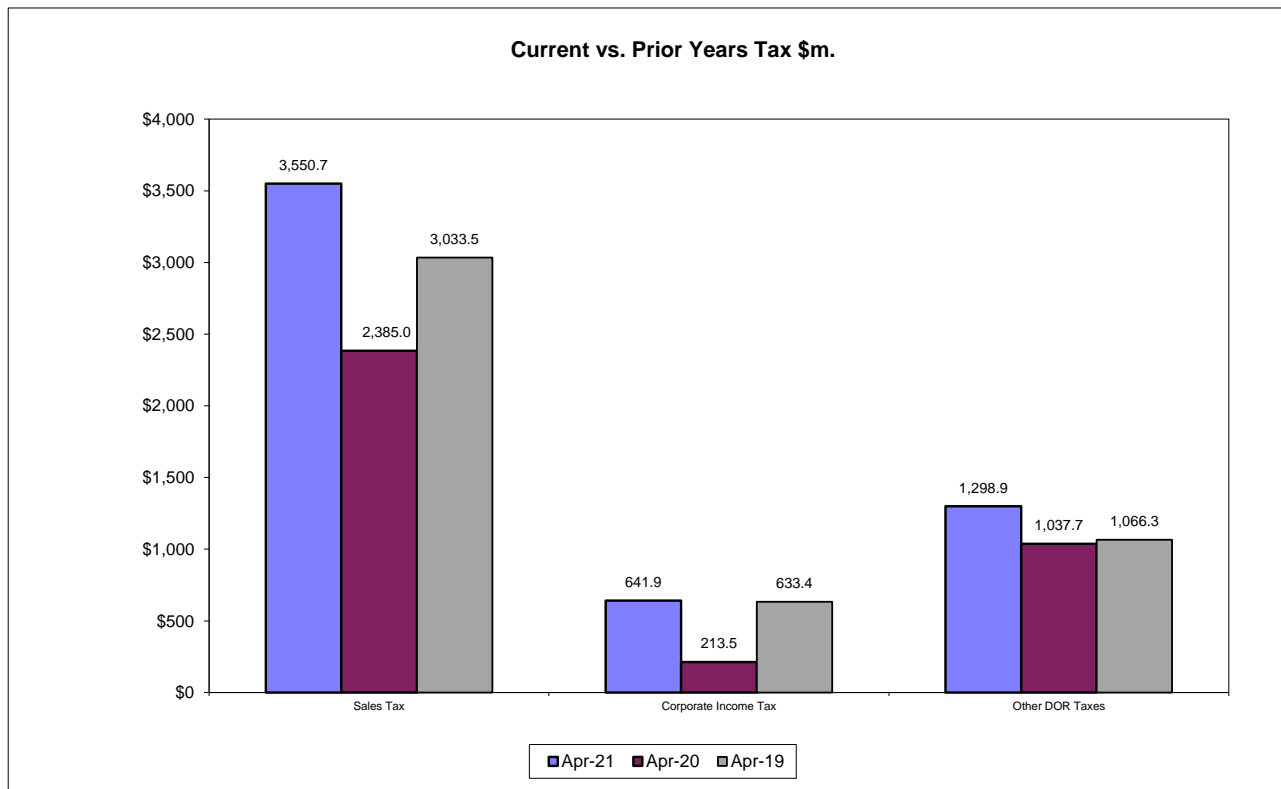
CIT collections of \$641.9m in April 2021 were over the April 2020 collections by \$428.4m (200.7%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

**DOCUMENTARY STAMP TAX**

Documentary Stamp Tax collections of \$394.9m were above the April 2020 collections by \$155.4m (64.9%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

# OTHER DOR TAXES...

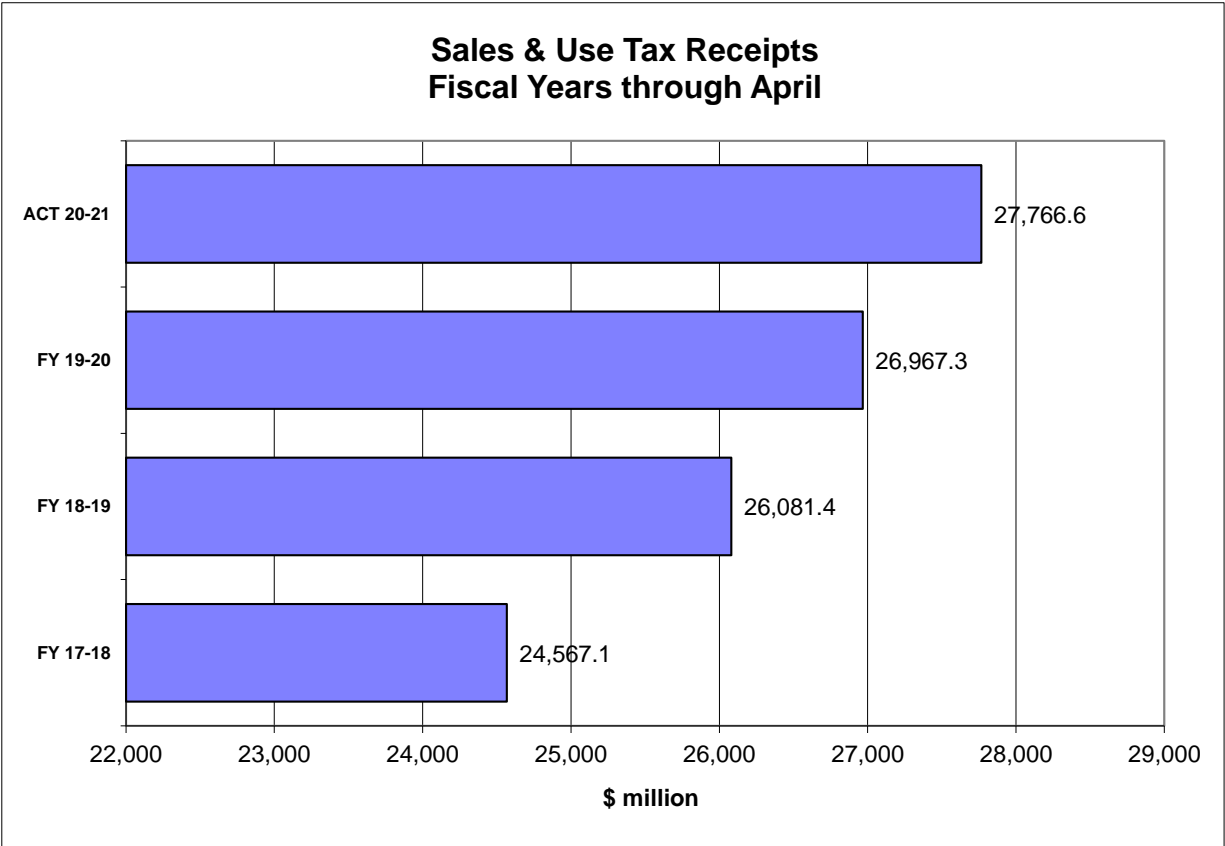
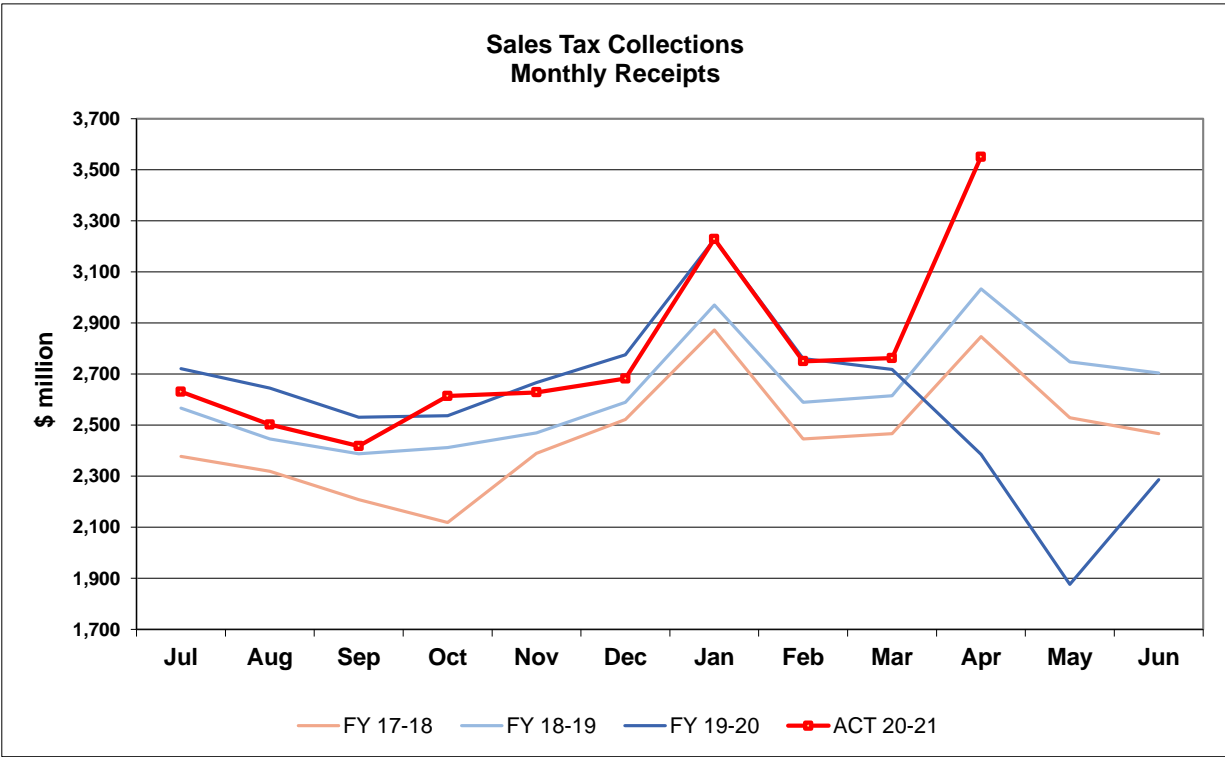
...excluding Sales Tax and Corporate Income Tax, other taxes contributed \$1298.9m to DOR tax collections in April 2021. The April 2021 collections were \$261.3m (25.2%) above the same month previous year's collections. The Doc Stamp Collections in April 2021 were \$394.9m. Compared to April 2020 collections on Doc Stamp Taxes, the April 2021 collections were \$155.4m (64.9%) above.

The April 2021 collections of the Communications Services Tax compared to April 2020 collections were \$1.7m (-1.2%) below. The collections of Insurance Premium Tax in April were 245.1m. Compared to April 2020 collections on Insurance Premium Taxes, the April 2021 collections were \$13.8m (6.1%) above. The collections of Fuel-related Taxes & Fees in April were above the prior year by \$60.2m (18.6%). The non-recurring Intangible Tax collections were \$20.6m (46.8%) above the prior year.

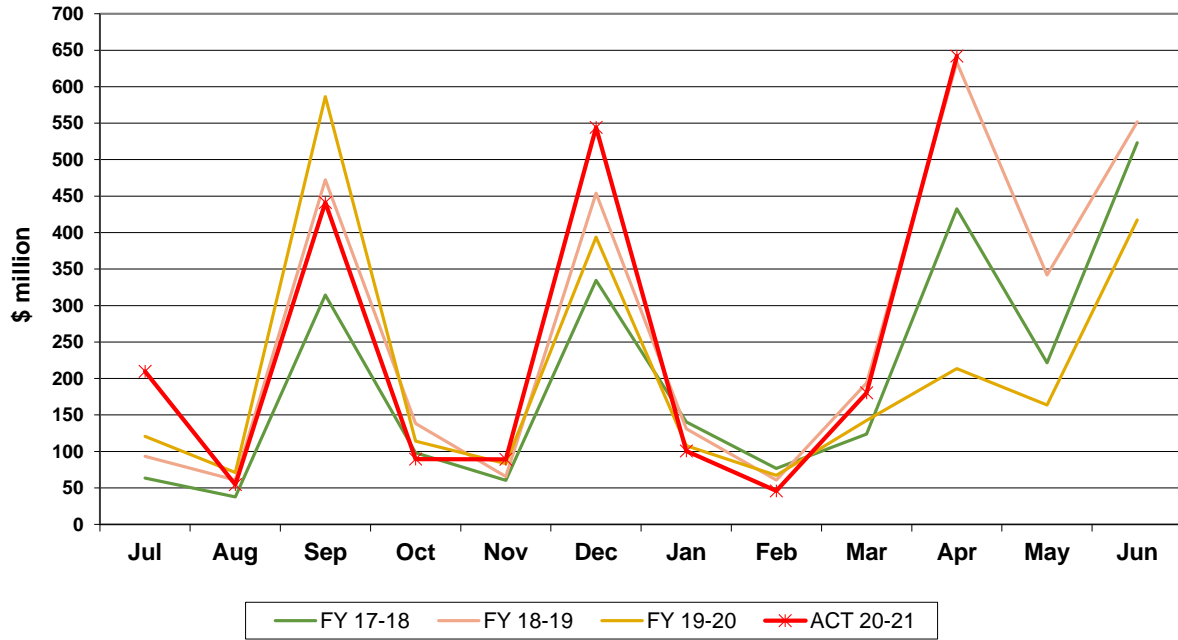


## HISTORICAL COMPARISON GRAPHS

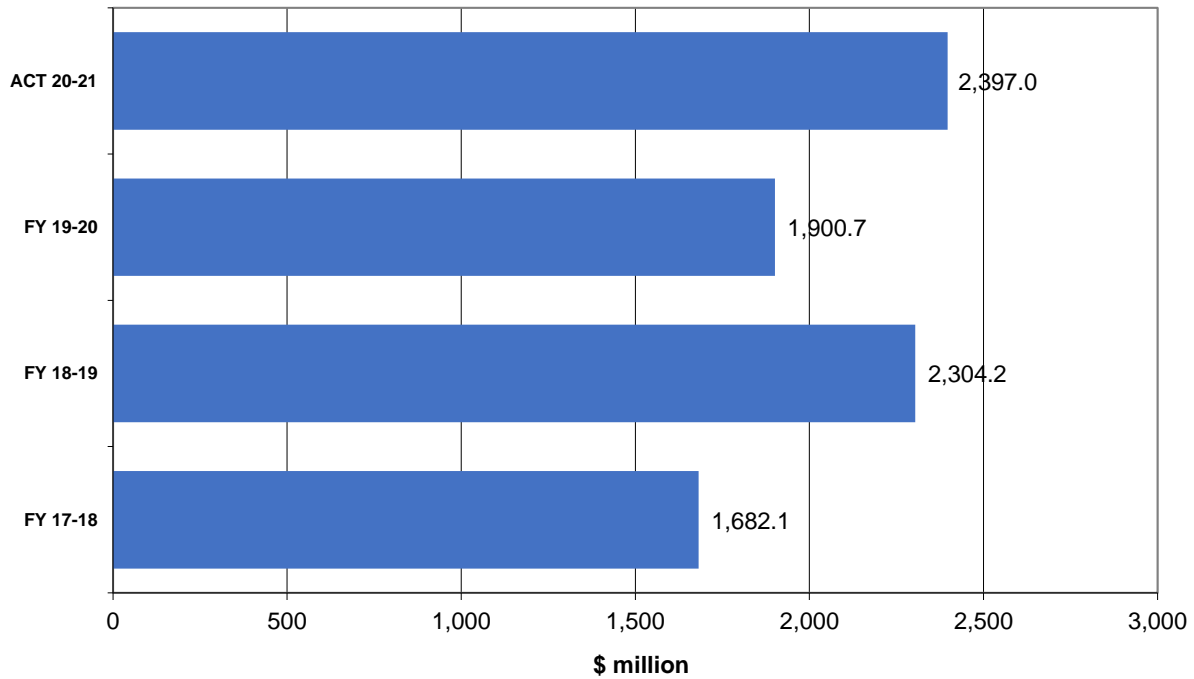

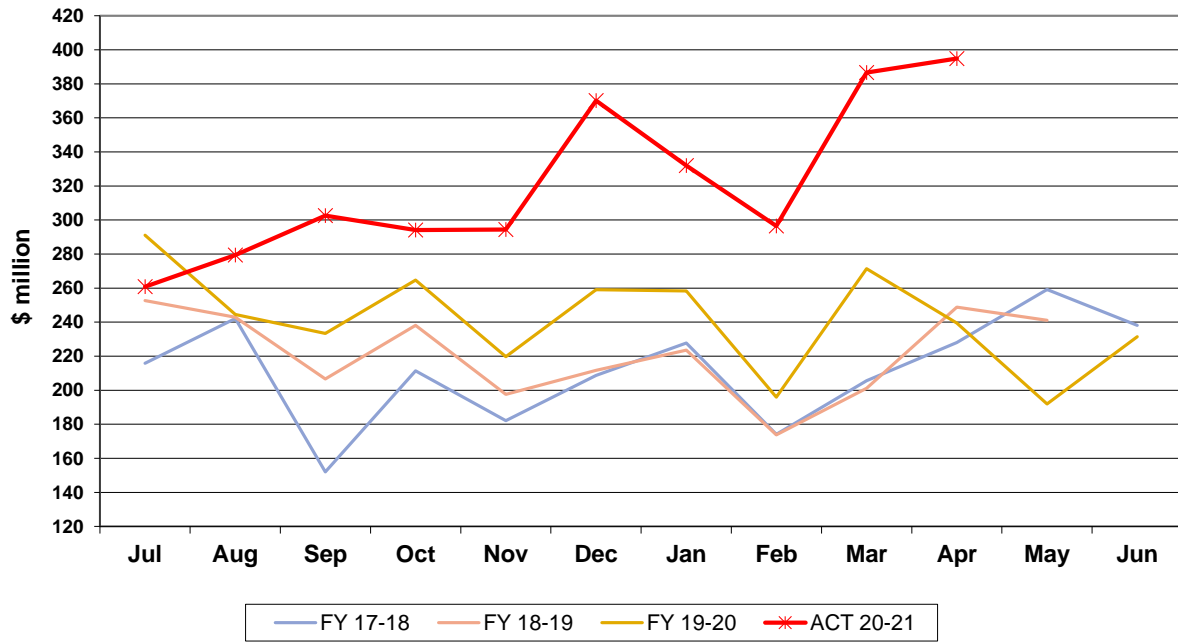
### Corporate Tax Collections Monthly Receipts



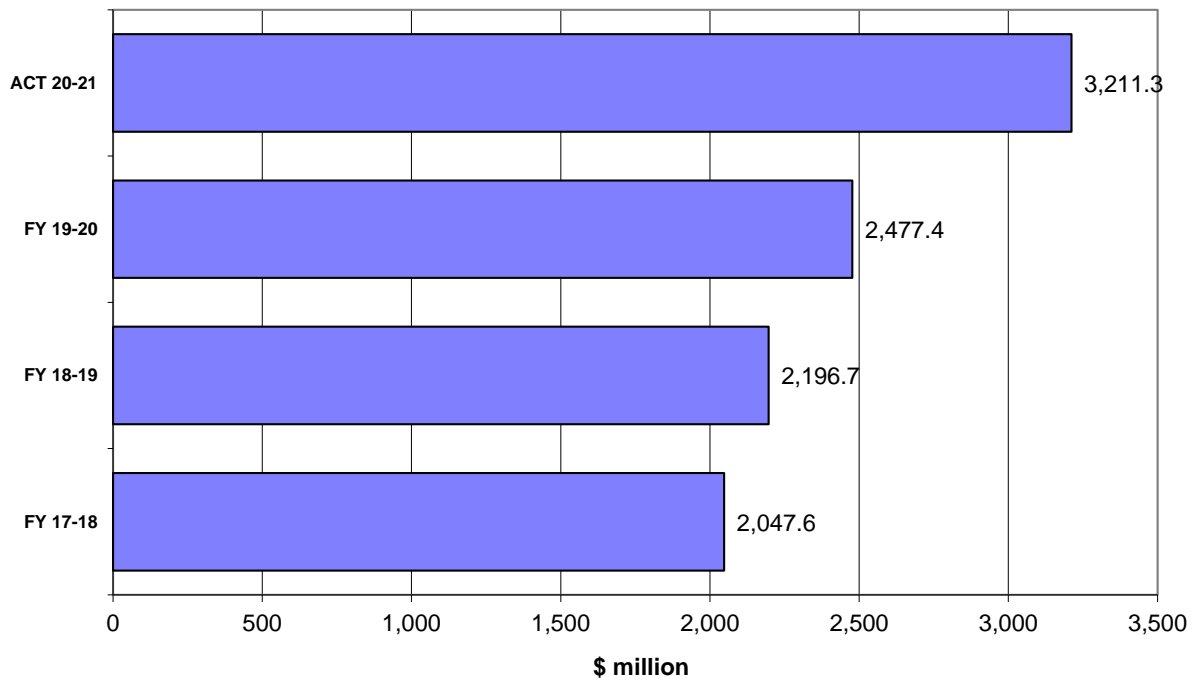
### Corporate Income Tax Receipts Fiscal Years through April



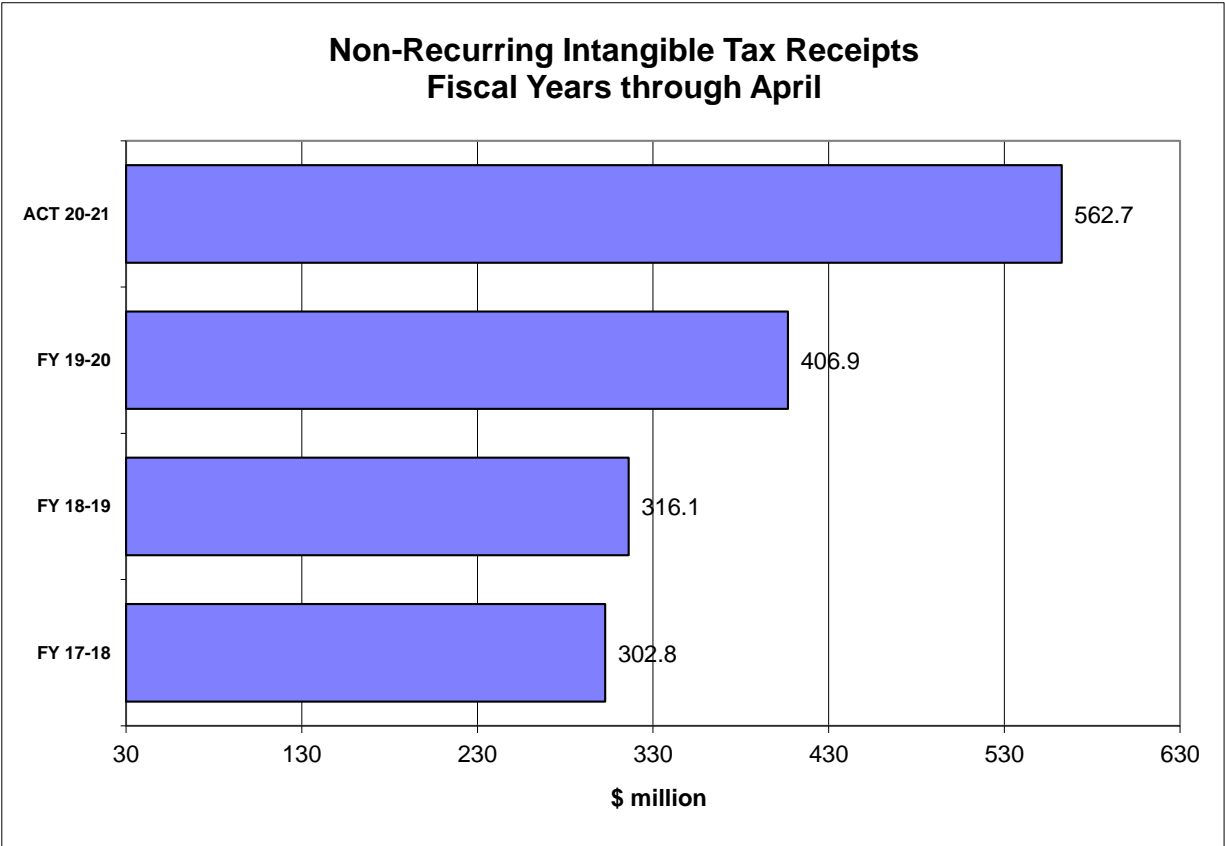
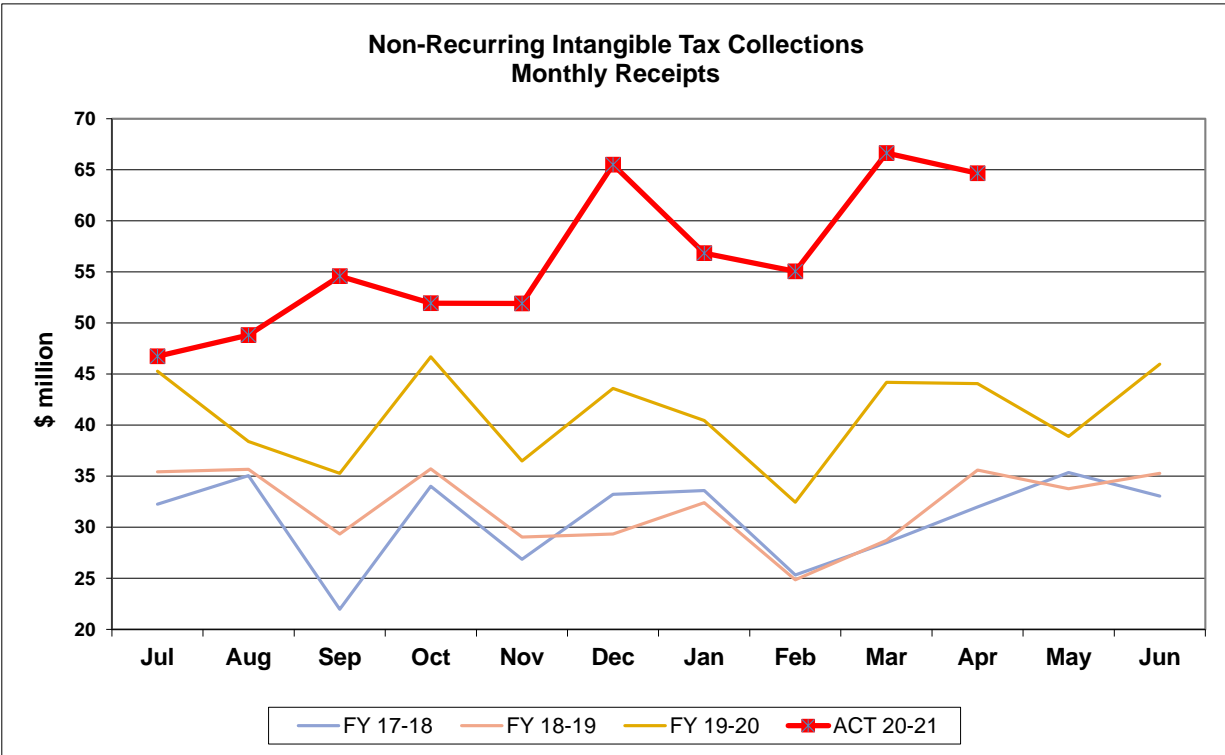
### Doc Stamps Tax Collections Monthly Receipts



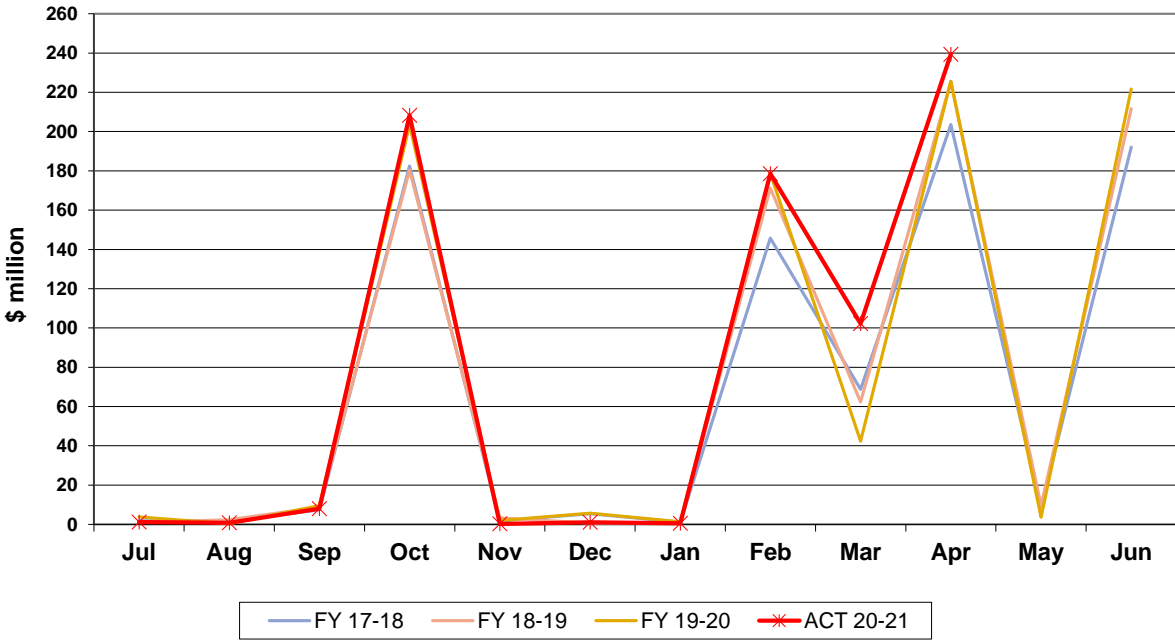
### Doc Stamps Tax Receipts Fiscal Years through April



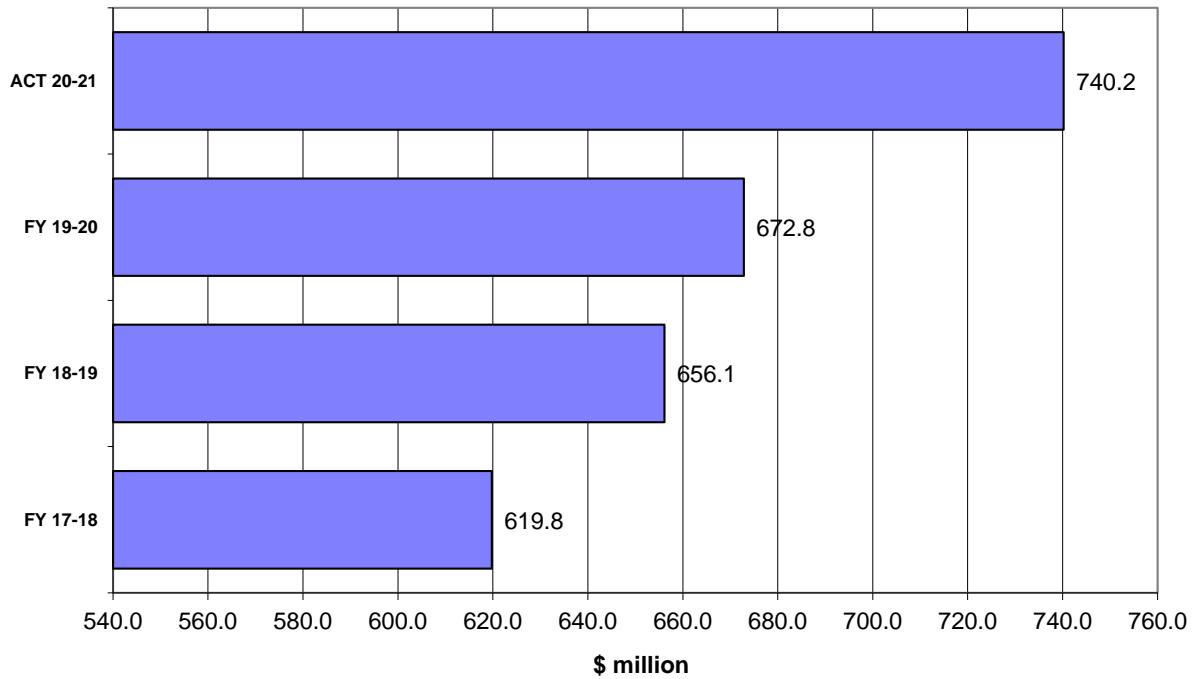




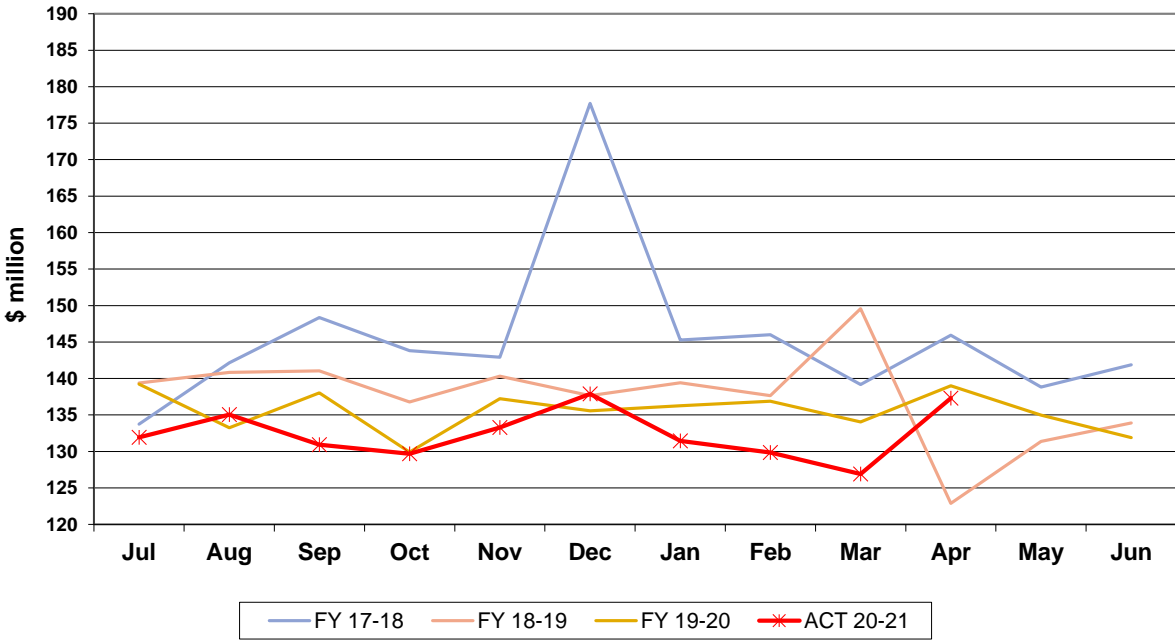
### Insurance Premium Tax Collections Monthly Receipts



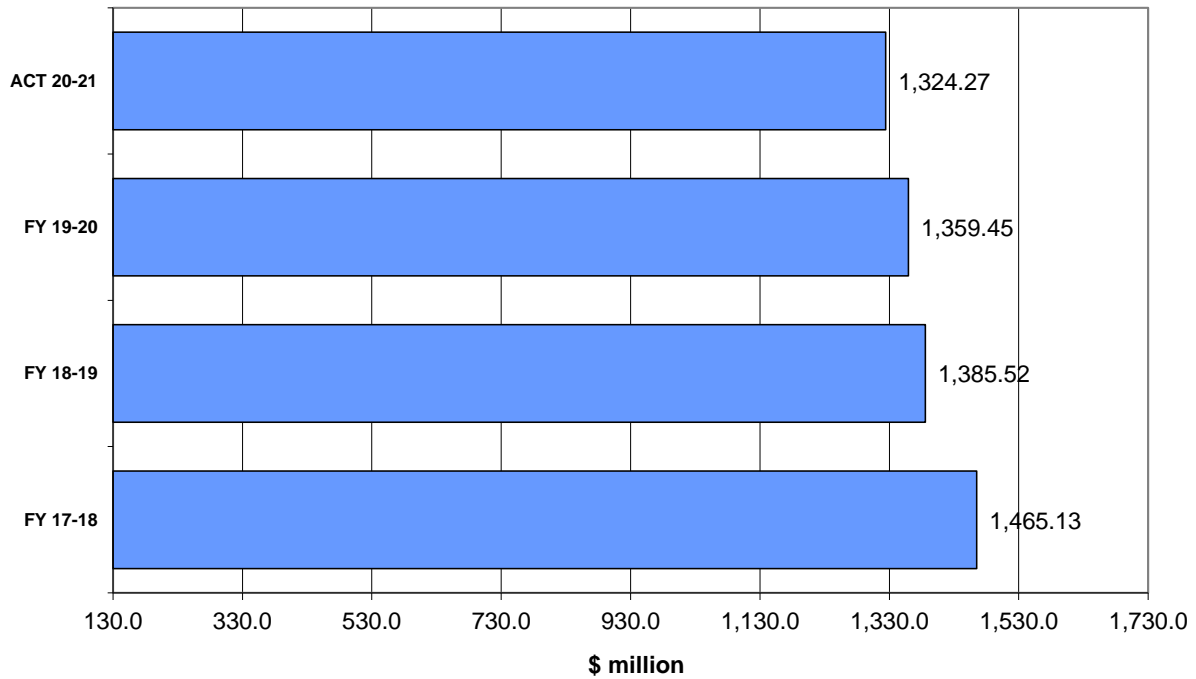
### Insurance Premium Tax Receipts Fiscal Years through April



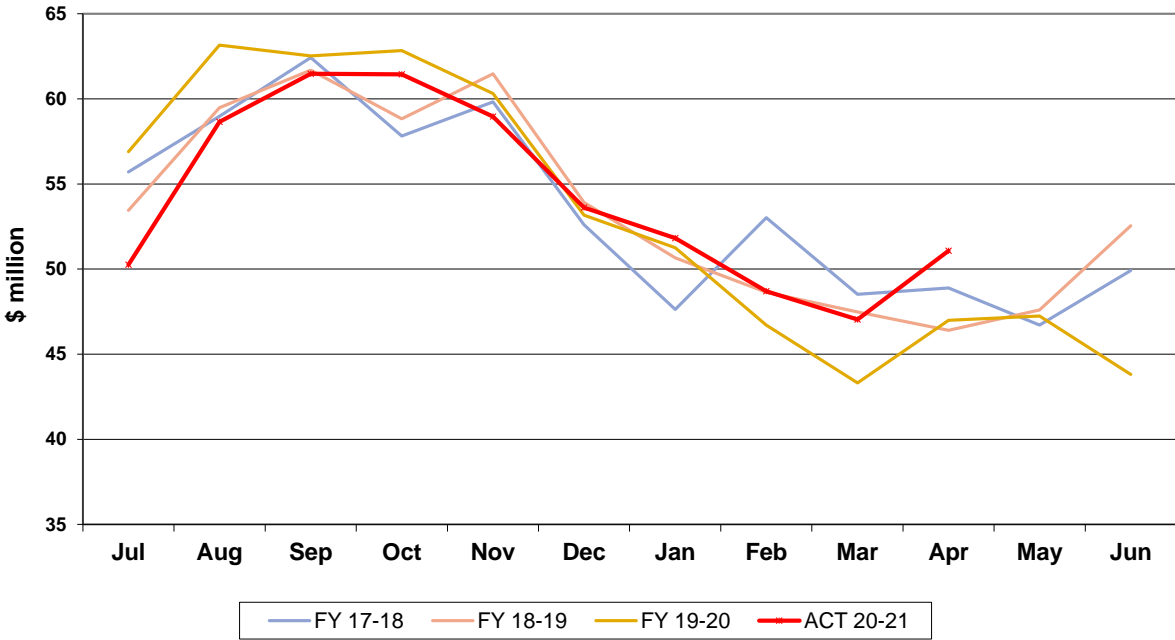

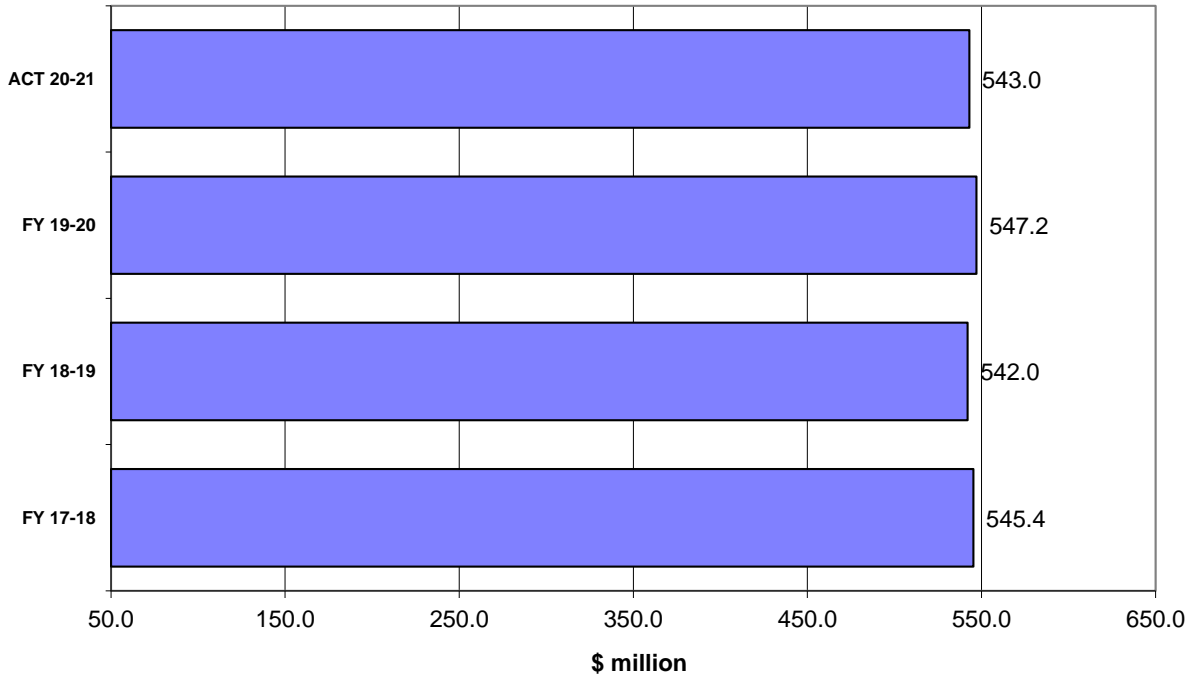

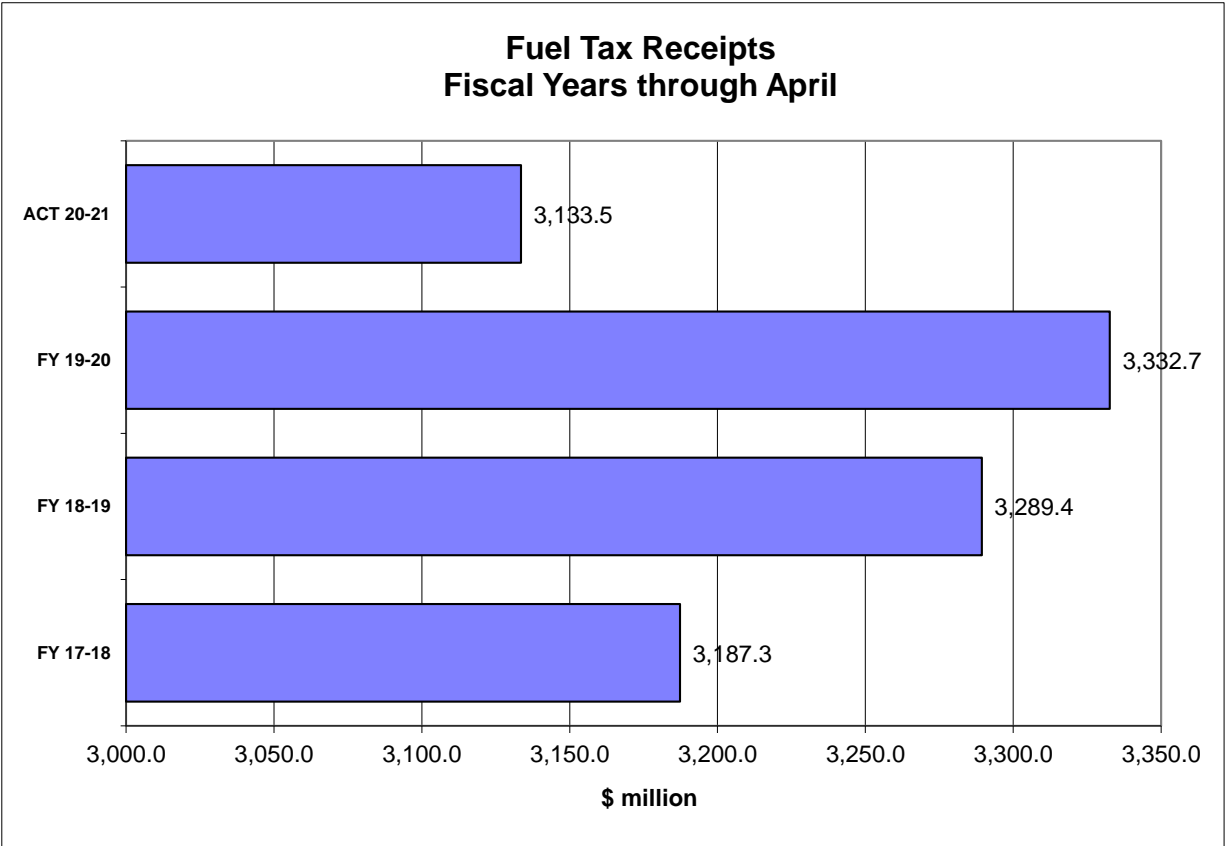
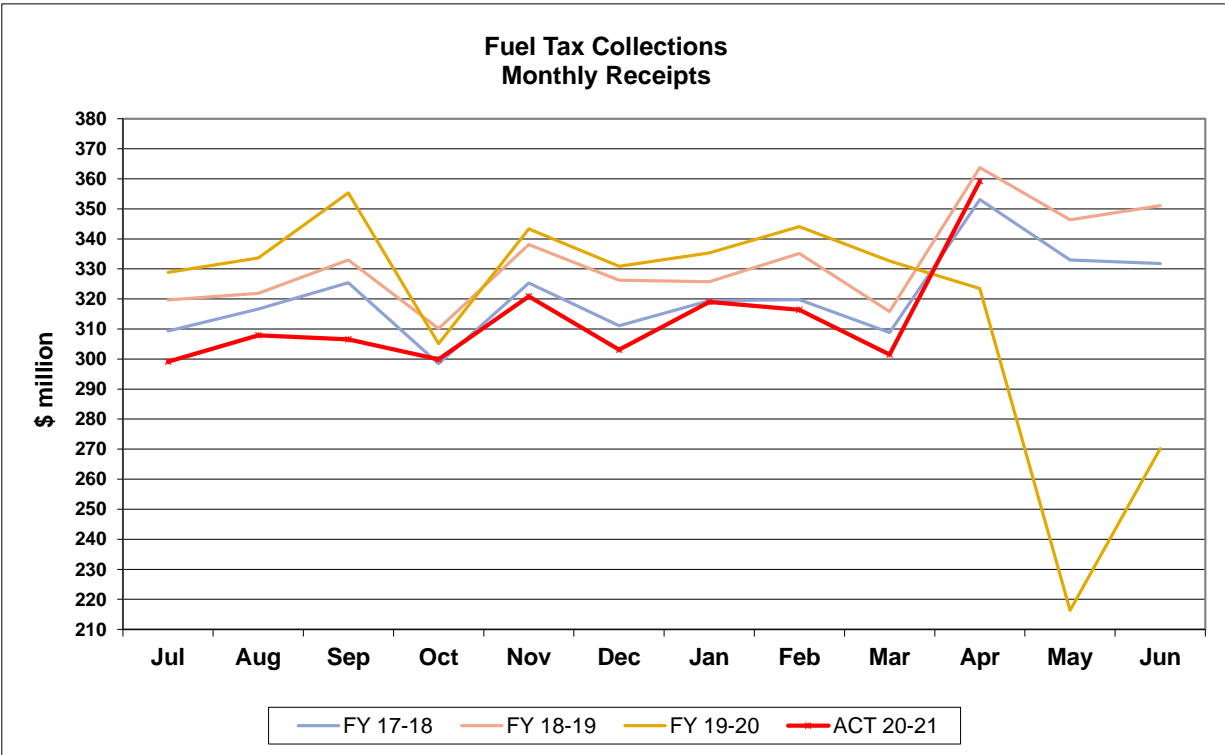


**2.5% Gross Receipts Tax Collections  
Monthly Receipts**

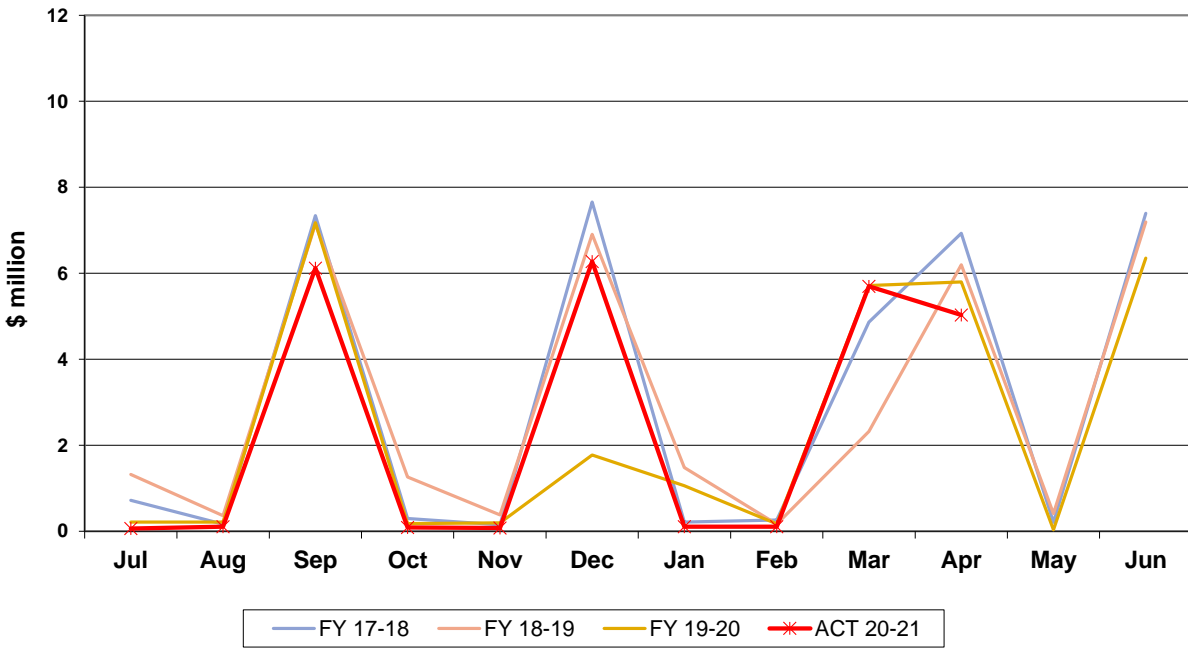
