SALES AND USE TAX

Sales and Use Tax collections were \$3,402.1m in July, and above the July 2020 collections by \$771.7m (29.3%). Collections for Sales Tax include Local Option Sales Tax and 2.6% Gross Receipts. These receipts are from the perspective of department collections and do not reflect collections of other state entities.

CORPORATE INCOME TAX

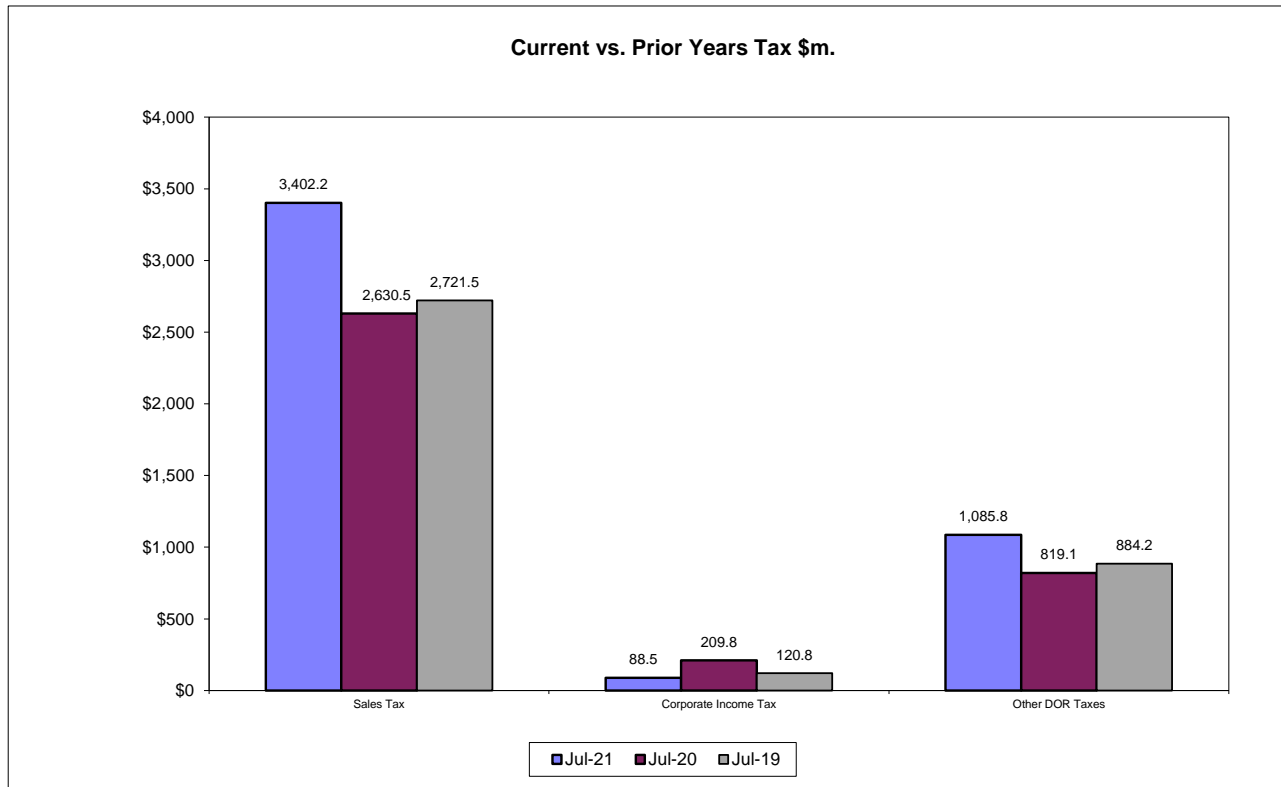
CIT collections of \$88.5m in July 2021 were under the July 2020 collections by \$121.3m (-57.8%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

DOCUMENTARY STAMP TAX

Documentary Stamp Tax collections of \$429.3m were above the July 2020 collections by \$168.5m (64.6%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

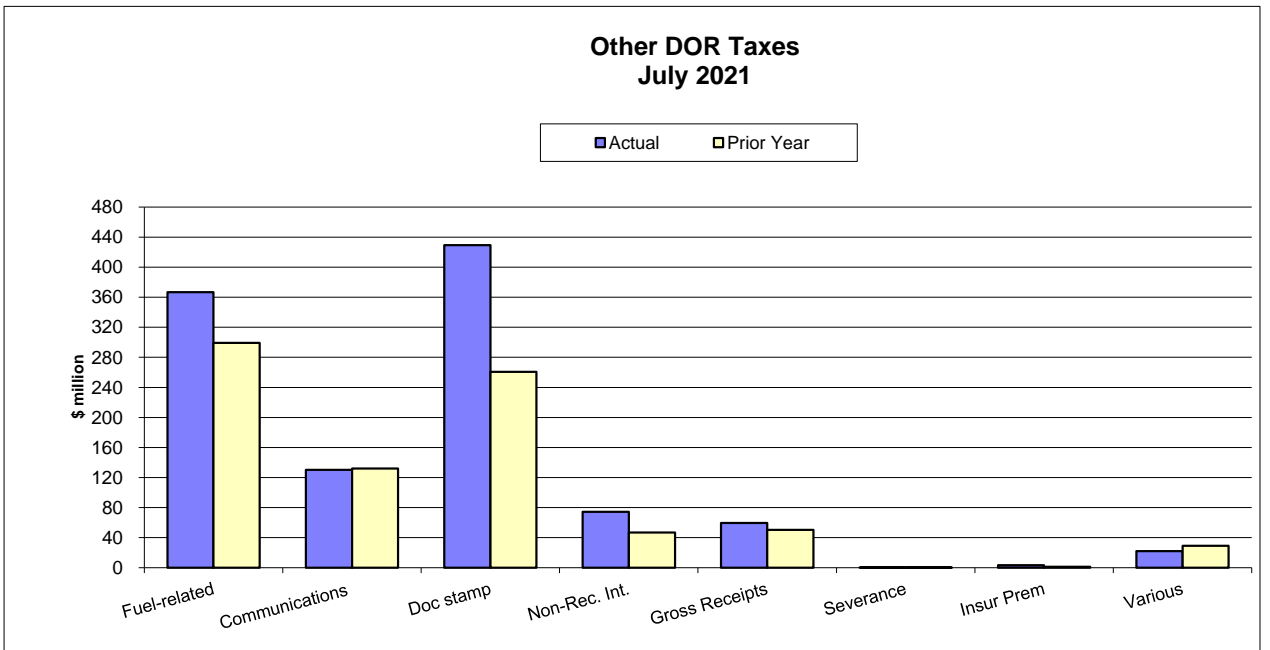
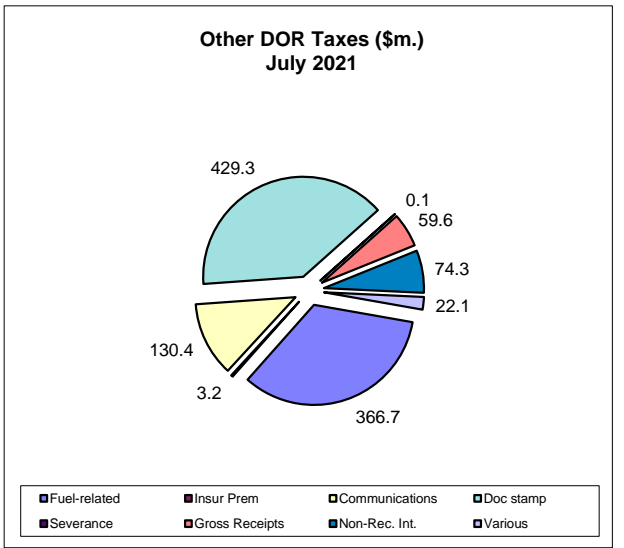
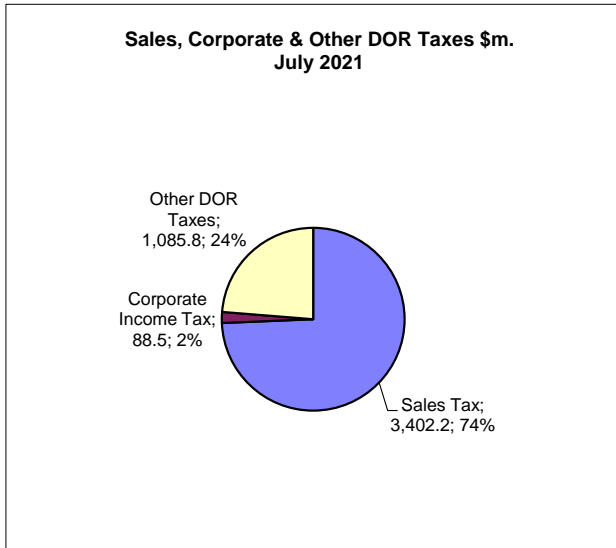
... COLLECTIONS of \$88.5m in July 2021 were under the July 2020 collections by \$121.3m (-57.8%).



OTHER DOR TAXES...

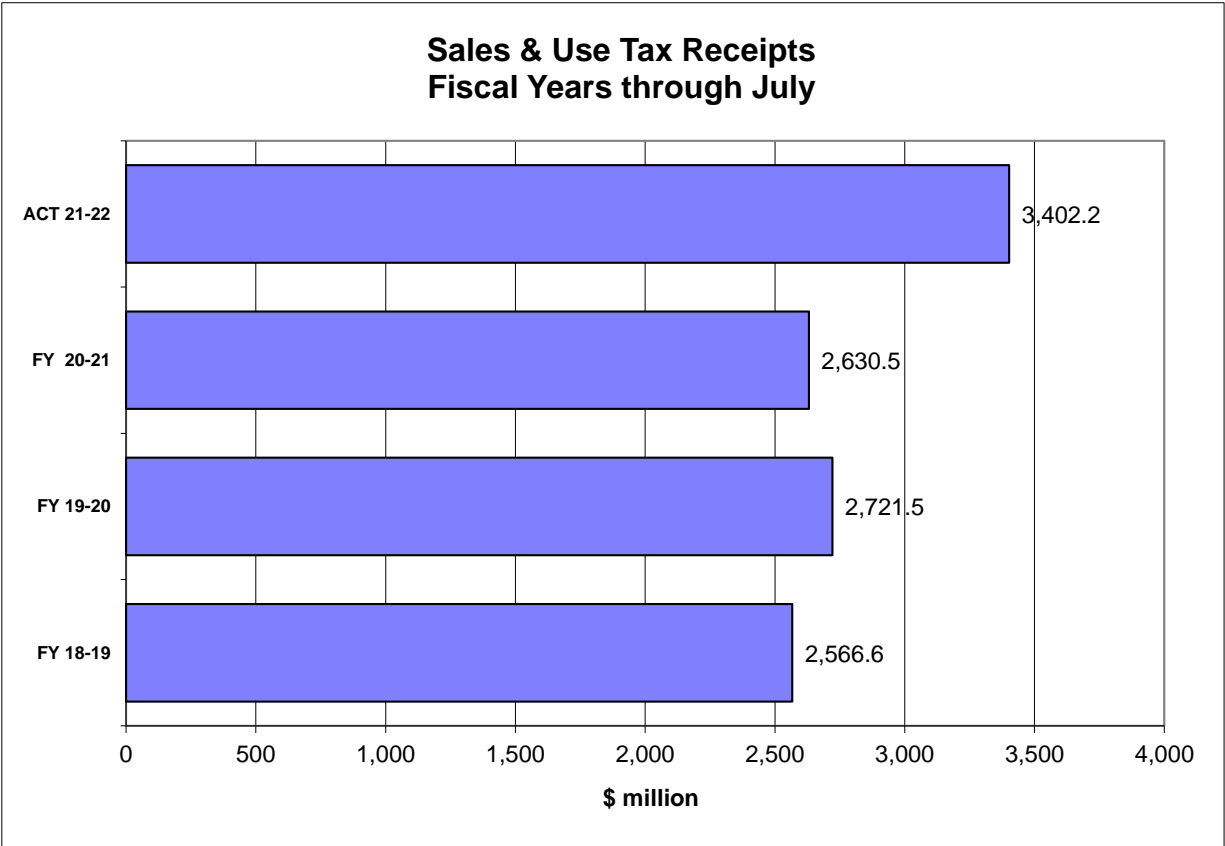
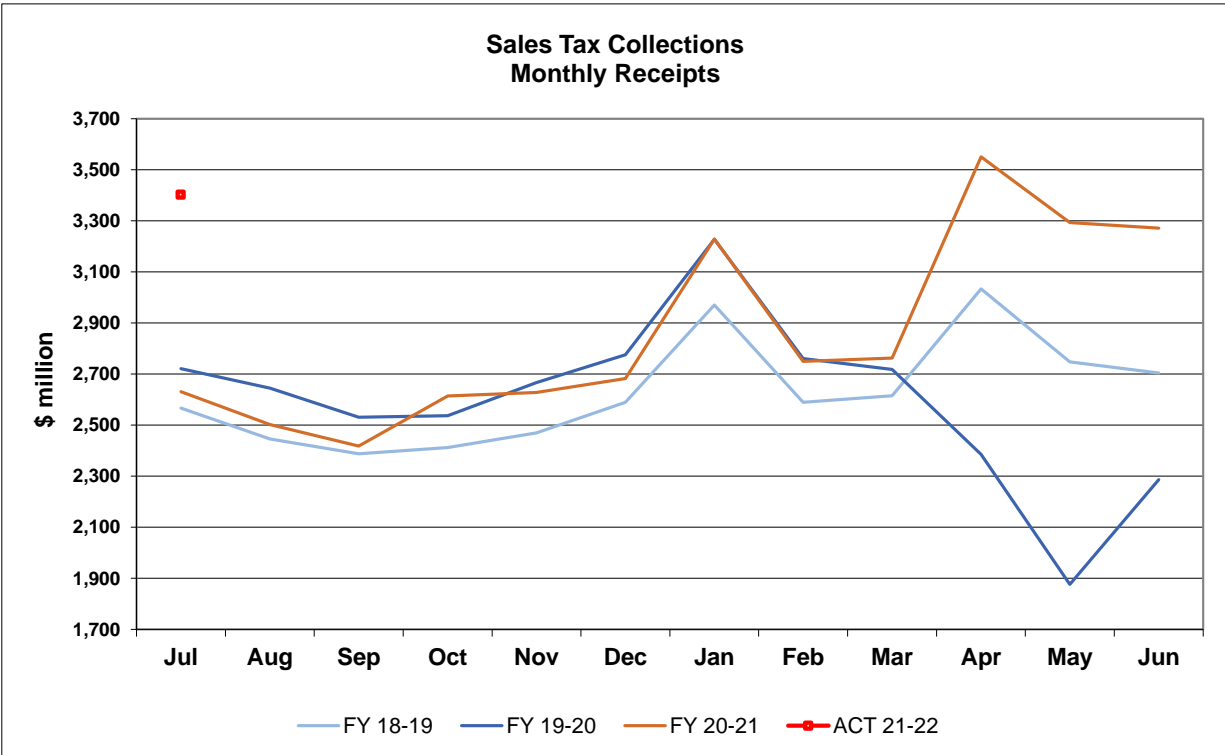
...excluding Sales Tax and Corporate Income Tax, other taxes contributed \$1085.8m to DOR tax collections in July 2021. The July 2021 collections were \$266.7m (32.6%) above the same month previous year's collections. The Doc Stamp Collections in July 2021 were \$429.3m. Compared to July 2020 collections on Doc Stamp Taxes, the July 2021 collections were \$168.5m (64.6%) above.

The July 2021 collections of the Communications Services Tax compared to July 2020 collections were \$1.5m (-1.1%) below. The collections of Insurance Premium Tax in July were 2m. Compared to July 2020 collections on Insurance Premium Taxes, the July 2021 collections were \$2m (176.6%) above. The collections of Fuel-related Taxes & Fees in July were above the prior year by \$67.6m (22.6%). The non-recurring Intangible Tax collections were \$27.6m (59%) above the prior year.

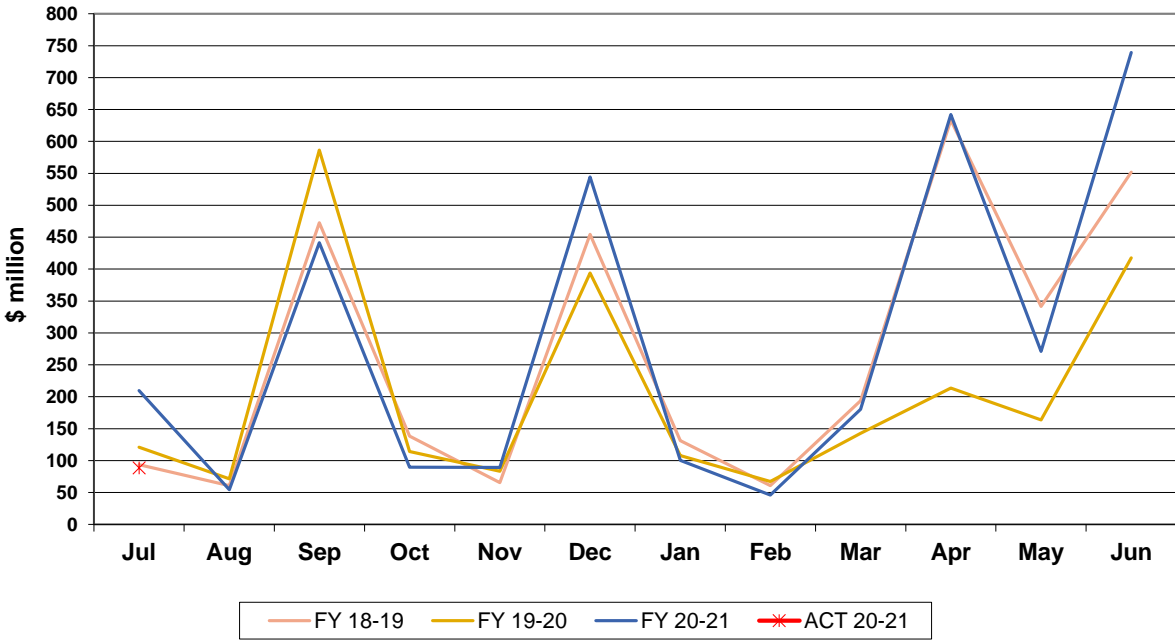


HISTORICAL COMPARISON GRAPHS

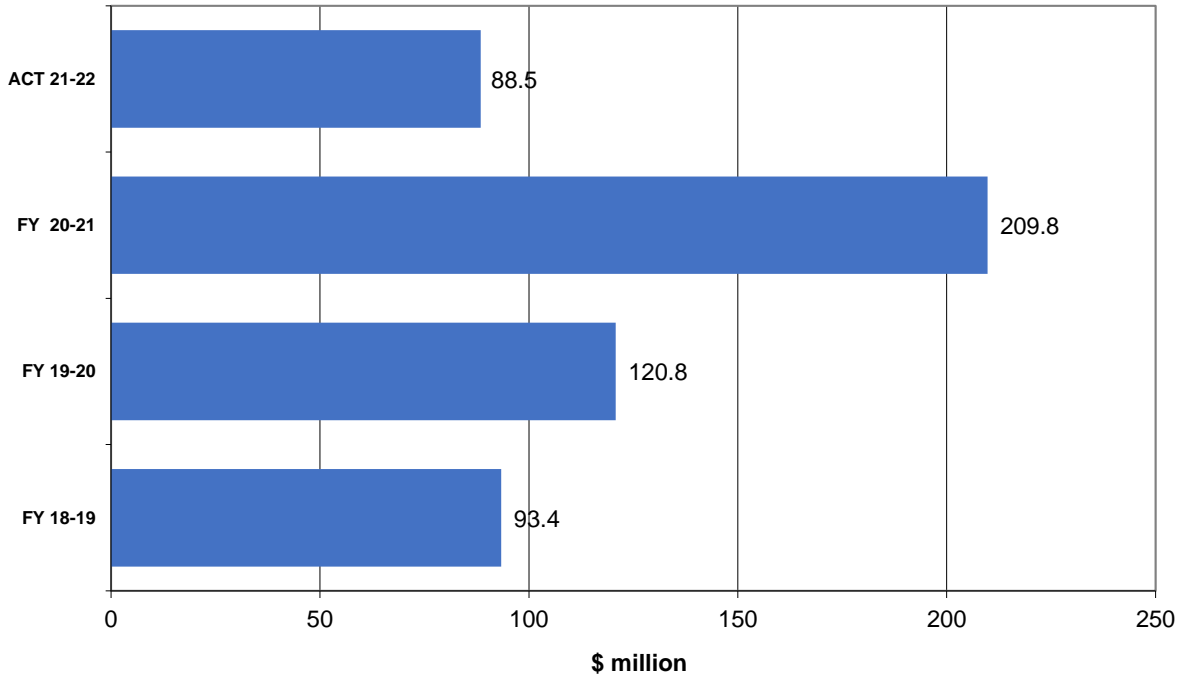

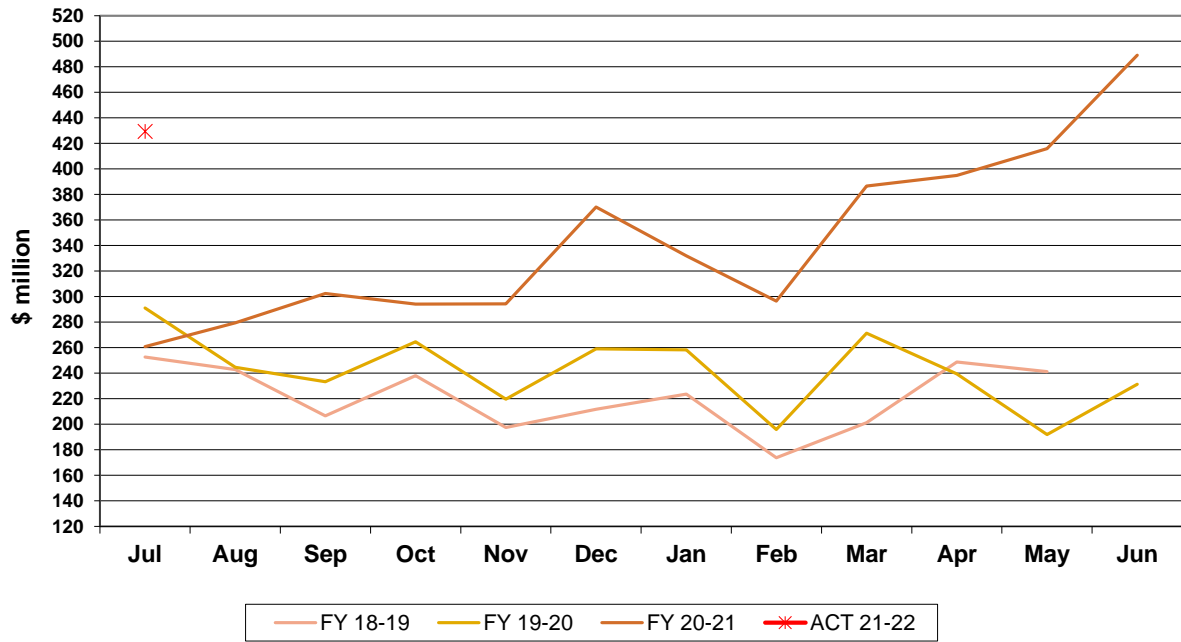
Corporate Tax Collections Monthly Receipts



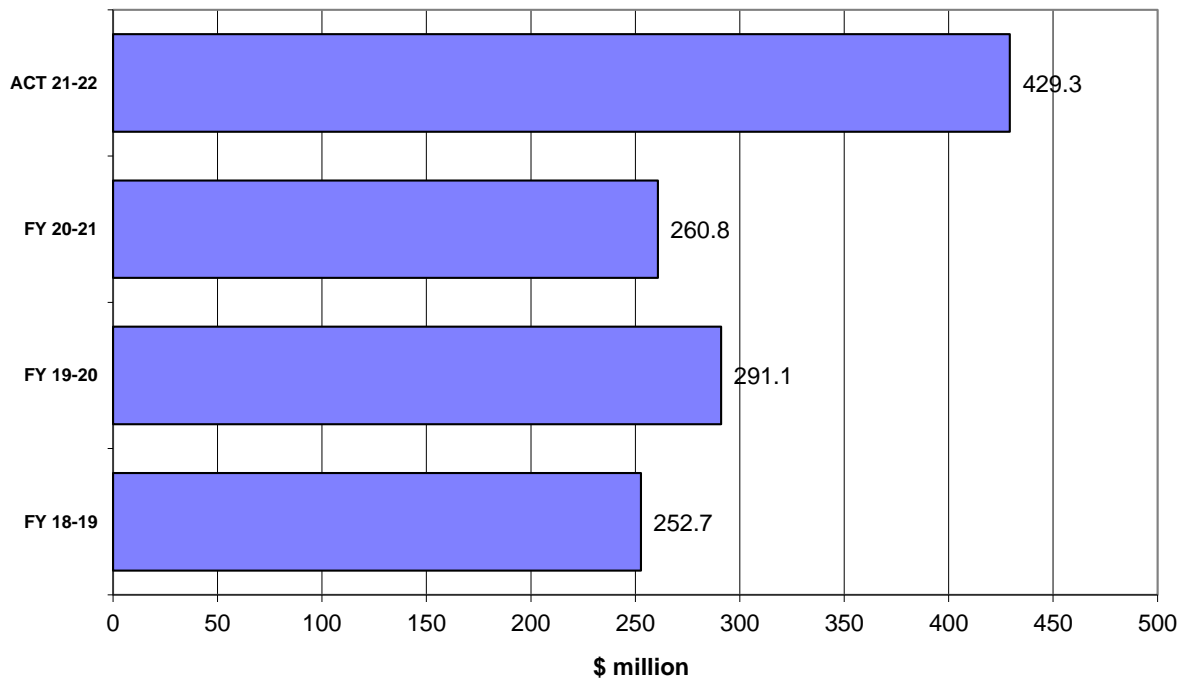
Corporate Income Tax Receipts Fiscal Years through July



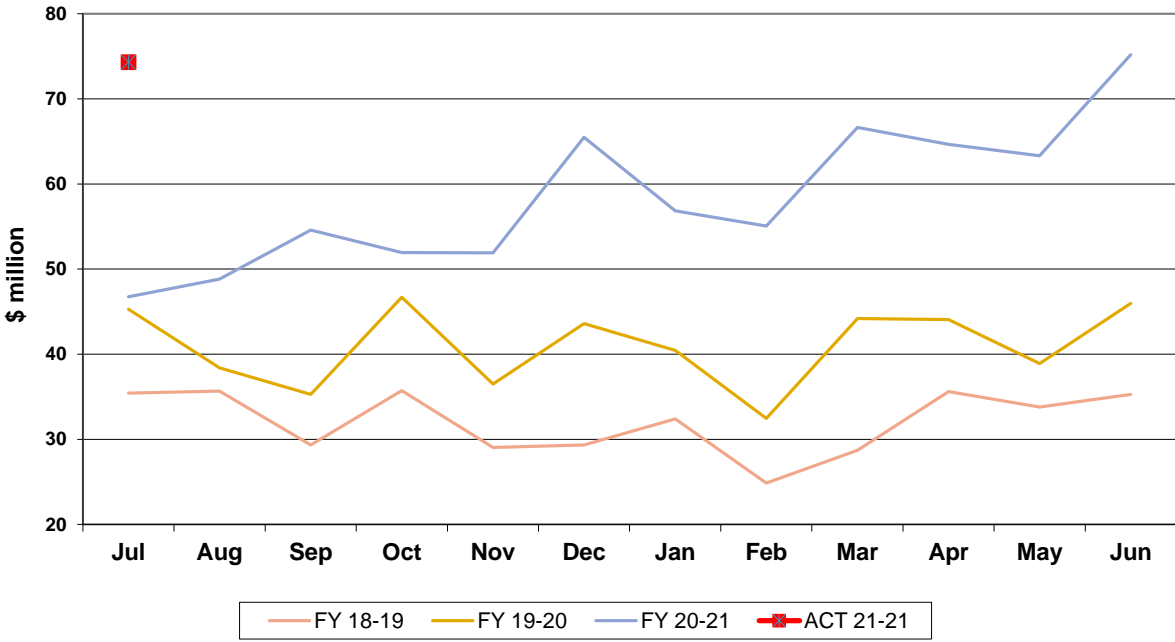
Doc Stamps Tax Collections Monthly Receipts



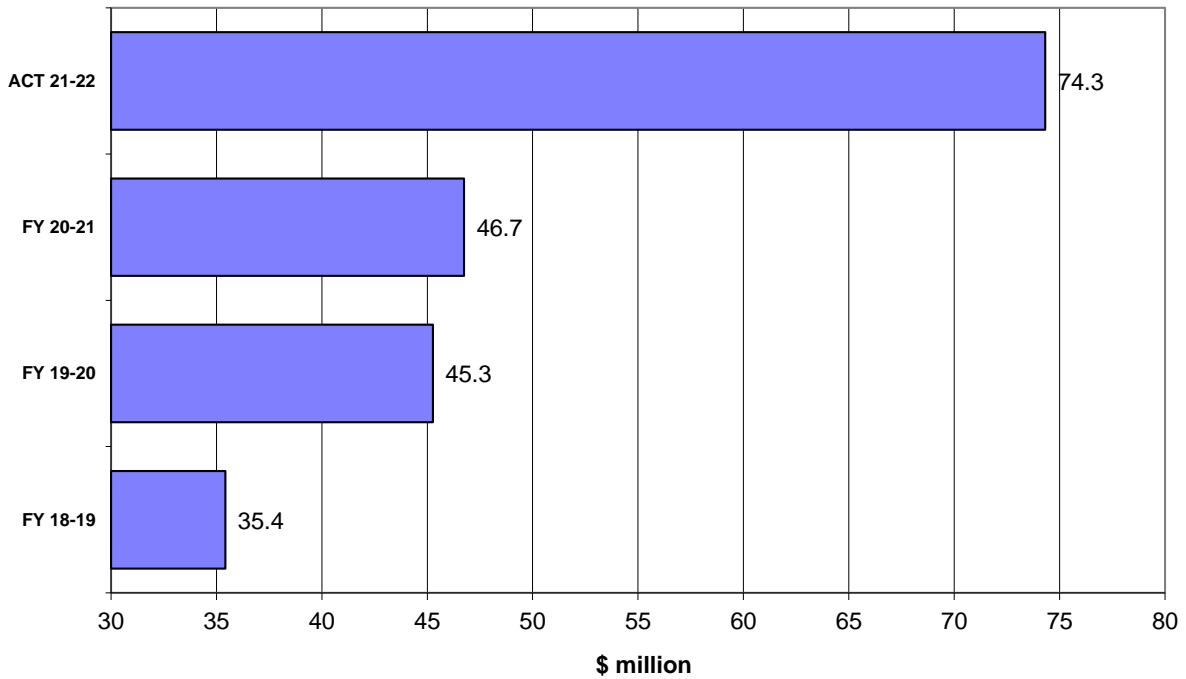
Doc Stamps Tax Receipts Fiscal Years through July



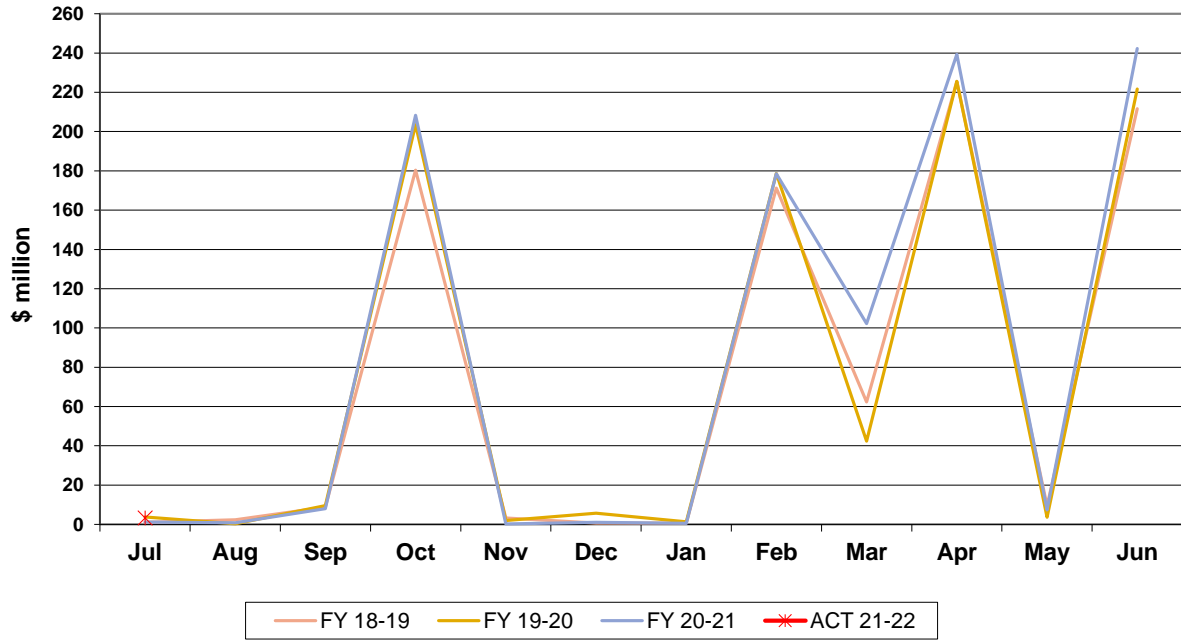
Non-Recurring Intangible Tax Collections Monthly Receipts



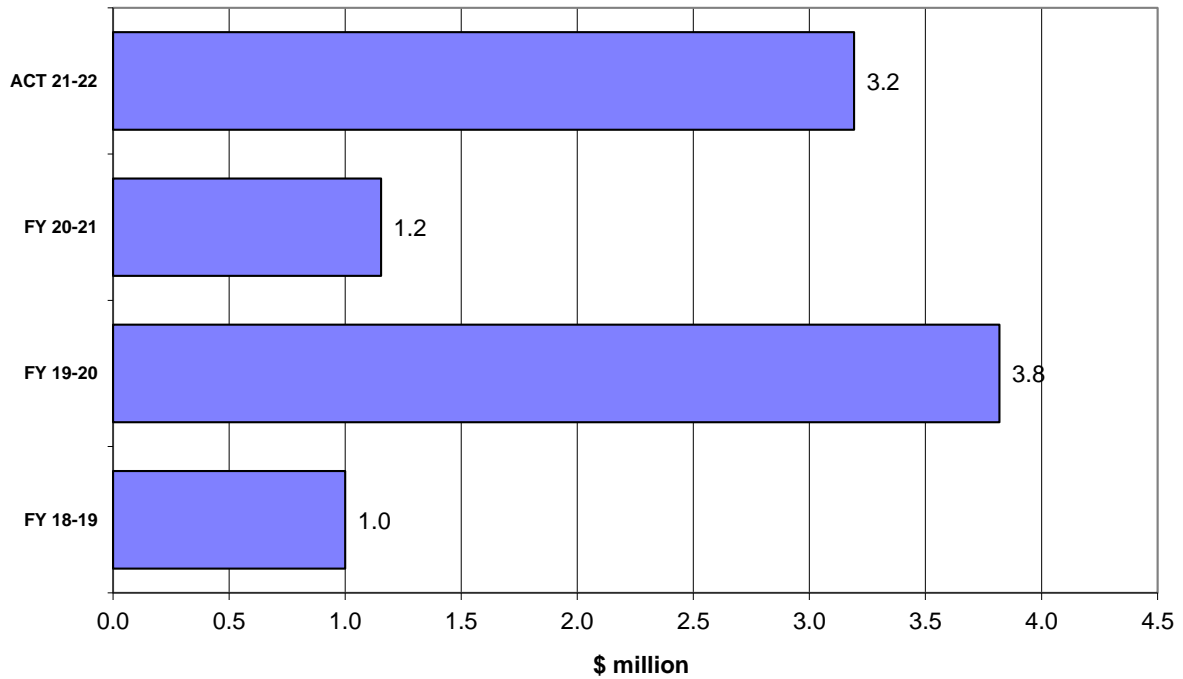
Non-Recurring Intangible Tax Receipts Fiscal Years through July



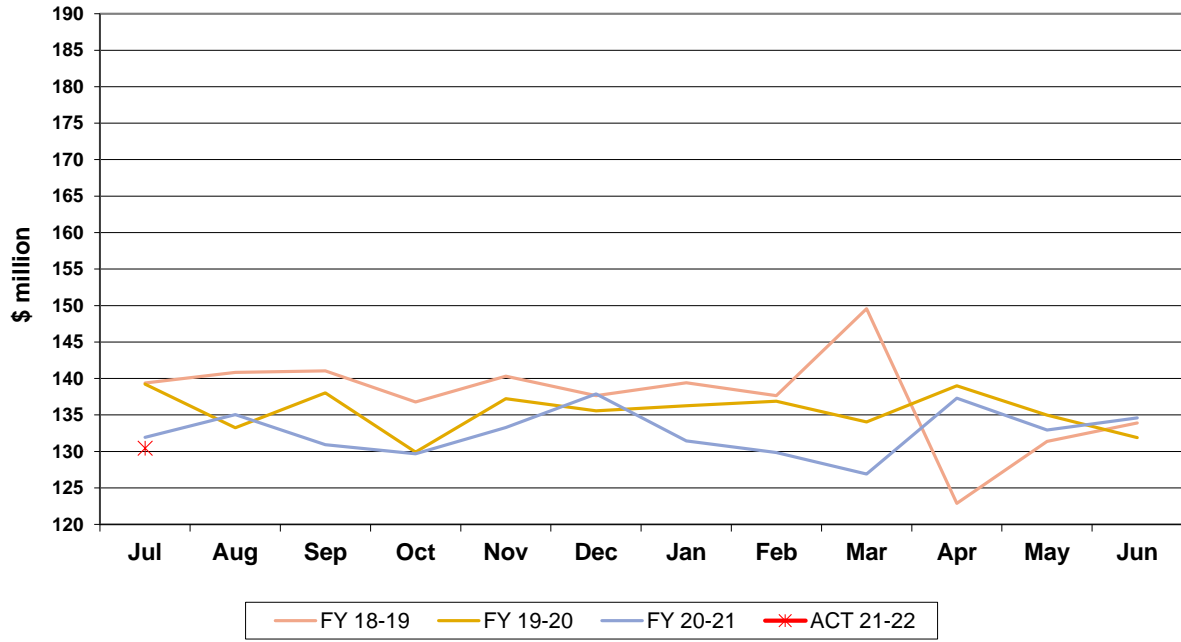
Insurance Premium Tax Collections Monthly Receipts



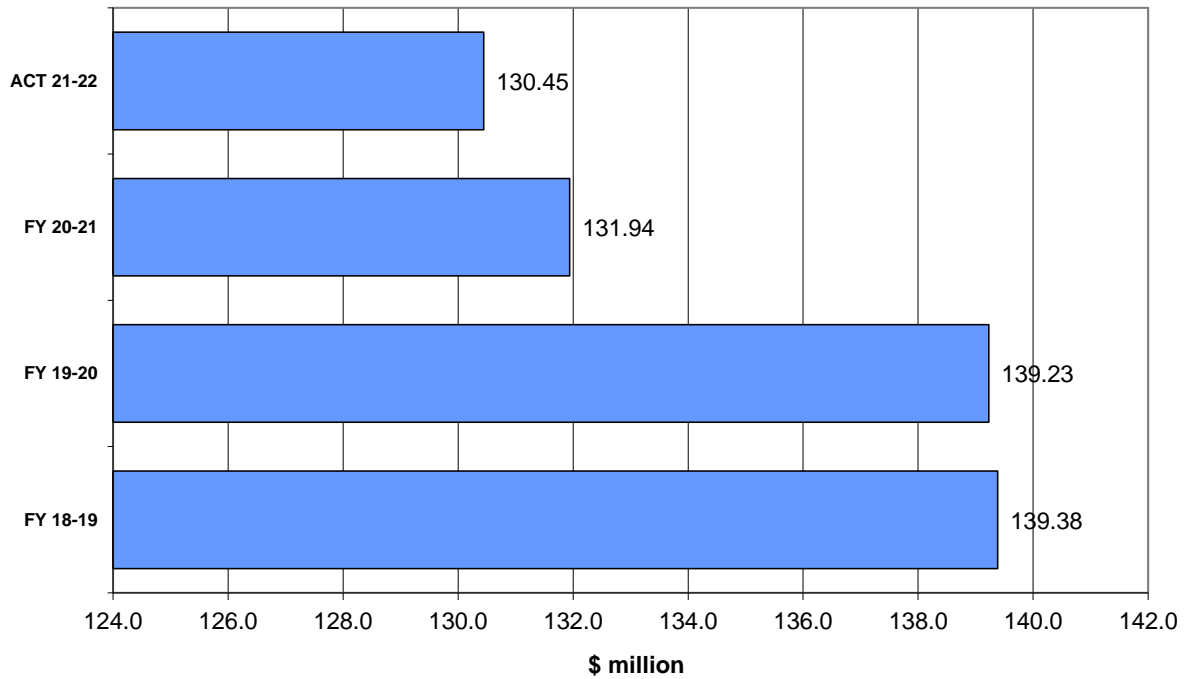
Insurance Premium Tax Receipts Fiscal Years through July



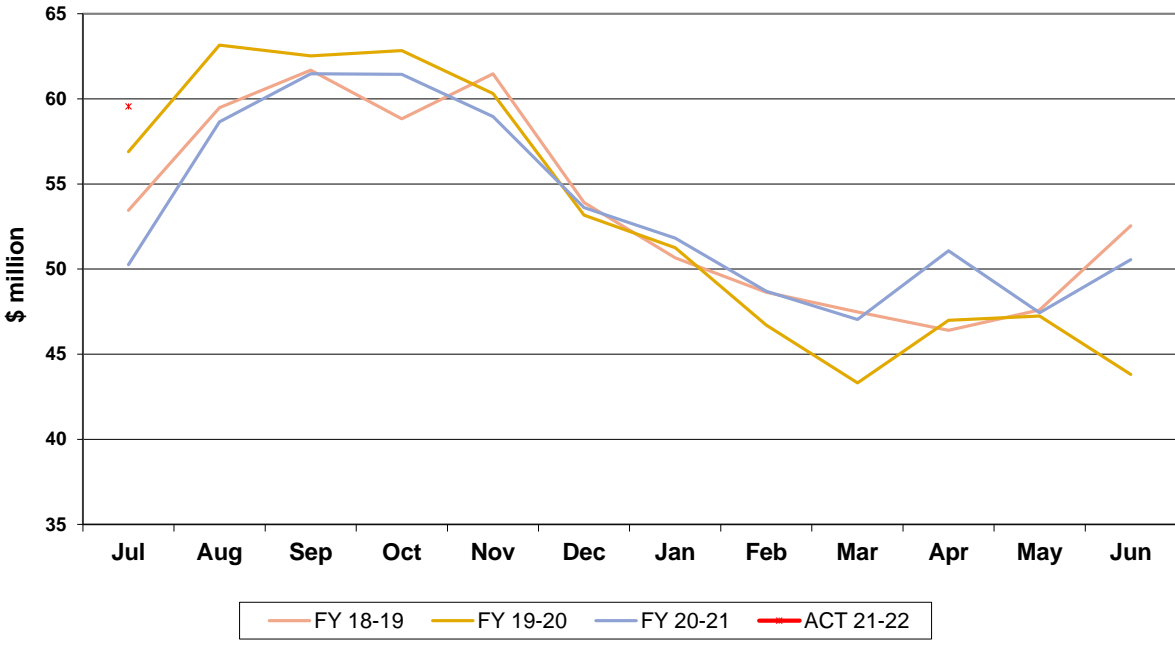
Communication Services Tax Collections Monthly Receipts



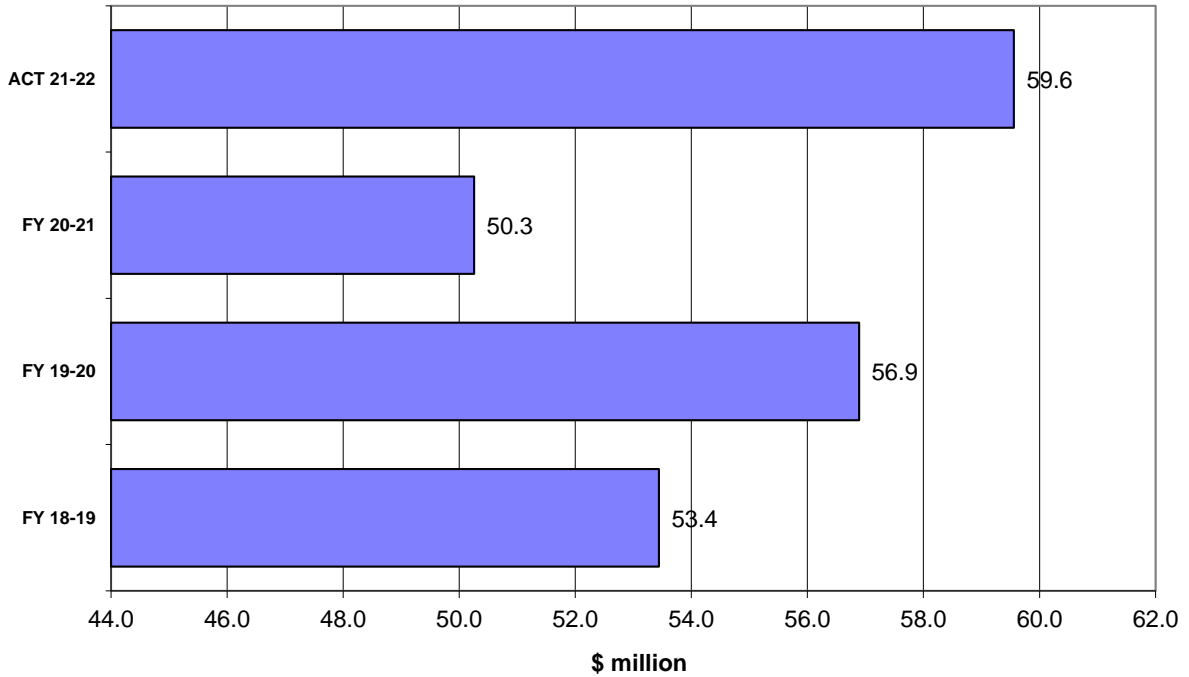
Communication Services Tax Receipts Fiscal Years through July



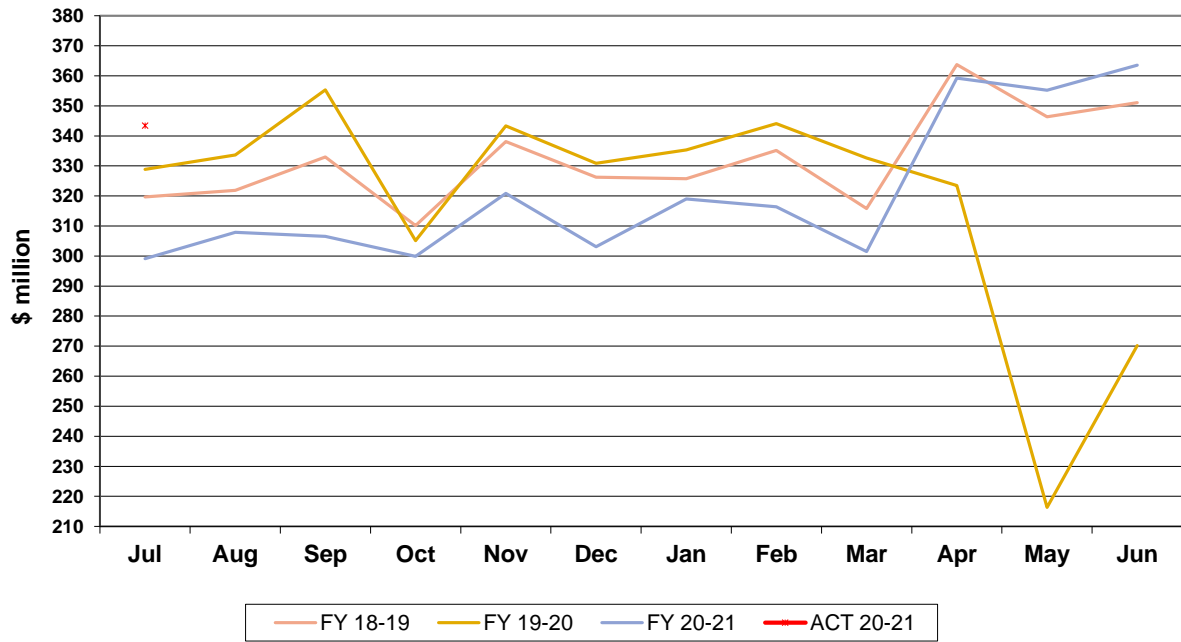
**2.5% Gross Receipts Tax Collections
Monthly Receipts**



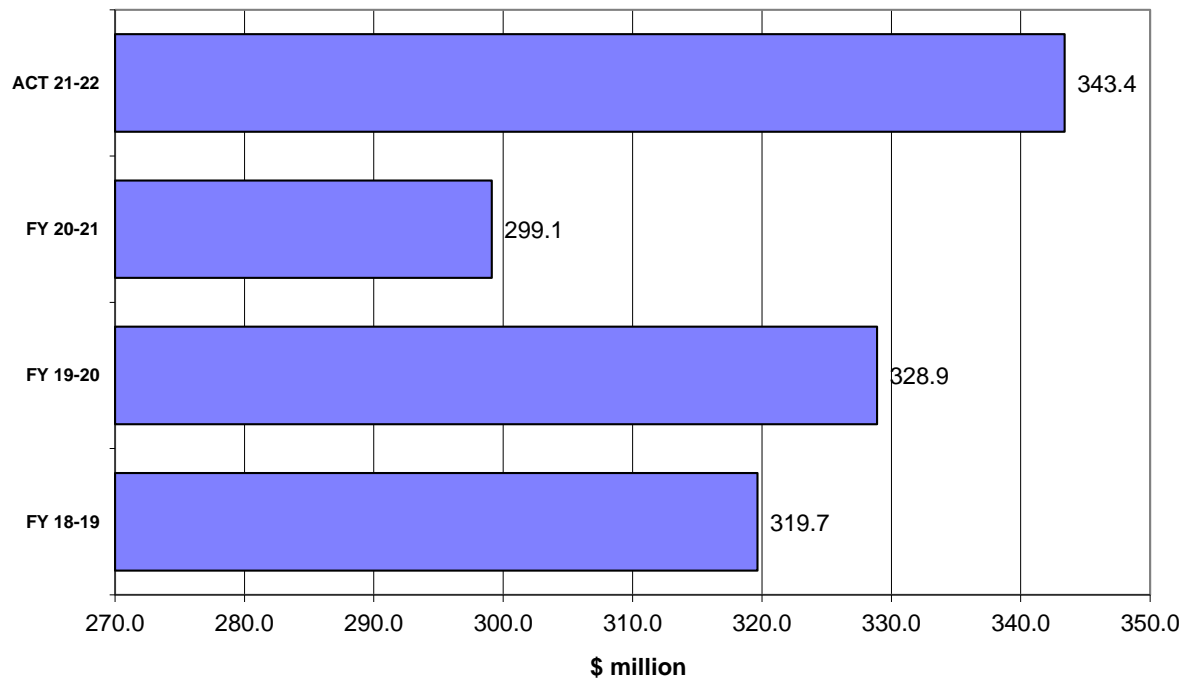

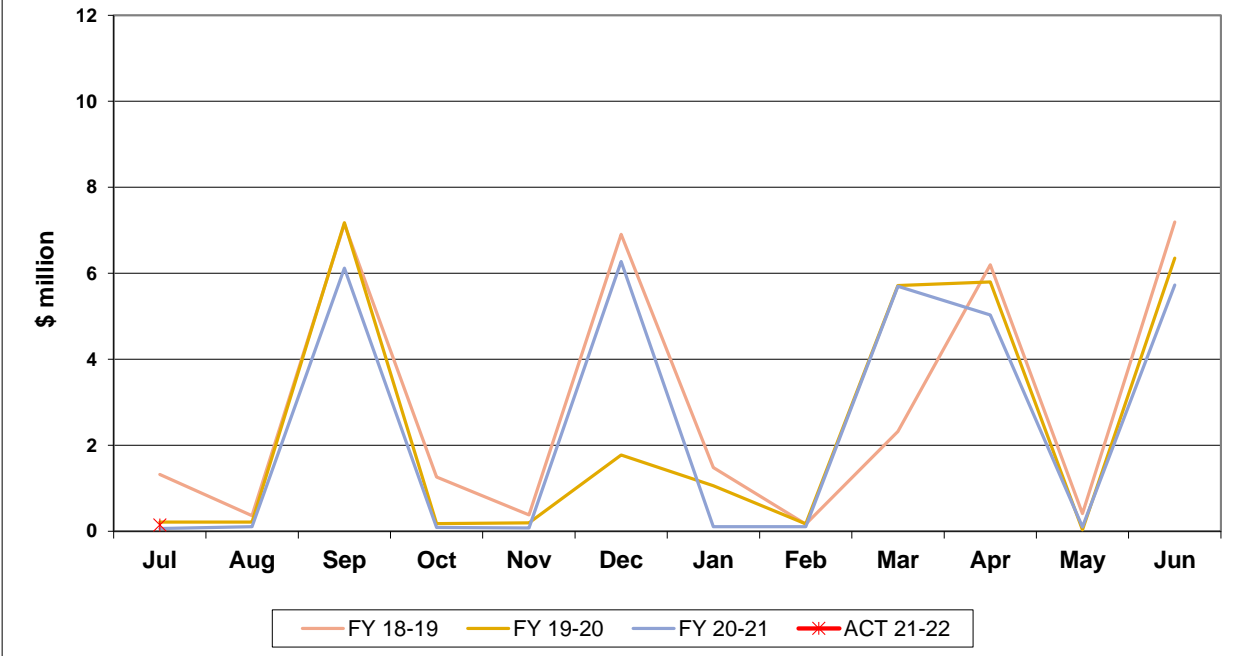
Fuel Tax Collections Monthly Receipts
