SALES AND USE TAX

Sales and Use Tax collections were \$3,347.5m in August, and above the August 2020 collections by \$845.8m (33.8%). Collections for Sales Tax include Local Option Sales Tax and 2.6% Gross Receipts. These receipts are from the perspective of department collections and do not reflect collections of other state entities.


CORPORATE INCOME TAX

CIT collections of \$69.1m in August 2021 were over the August 2020 collections by \$14.5m (26.7%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.

DOCUMENTARY STAMP TAX

Documentary Stamp Tax collections of \$458.8m were above the August 2020 collections by \$179.5m (64.2%). These receipts are from the perspective of department collections and do not reflect collections of other state entities.





CORPORATE INCOME TAX....

... COLLECTIONS of \$69.1m in August 2021 were over the August 2020 collections by \$14.5m (26.7%).





OTHER DOR TAXES...

...excluding Sales Tax and Corporate Income Tax, other taxes contributed \$1123m to DOR tax collections in August 2021. The August 2021 collections were \$278.1m (32.9%) above the same month previous year's collections. The Doc Stamp Collections in August 2021 were \$458.8m. Compared to August 2020 collections on Doc Stamp Taxes, the August 2021 collections were \$179.5m (64.2%) above.

The August 2021 collections of the Communications Services Tax compared to August 2020 collections were \$0.4m (0.3%) above. The collections of Insurance Premium Tax in August were 1.2m. Compared to August 2020 collections on Insurance Premium Taxes, the August 2021 collections were \$4.8m (617.5%) above. The collections of Fuel-related Taxes & Fees in August were above the prior year by \$63m (20.4%). The non-recurring Intangible Tax collections were \$24.3m (49.8%) above the prior year.
