#### **SALES AND USE TAX**

Sales and Use Tax collections were below the estimate in September 2019 by \$15.7m (-0.6%) and above the September 2018 collections by \$143.3m (6%). The estimates are based on the August 14, 2019 General Revenue Estimating Conference (GR) (page 3).

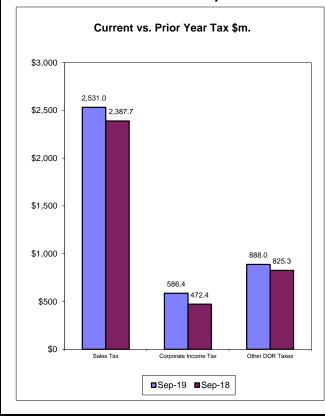
#### **CORPORATE INCOME TAX**

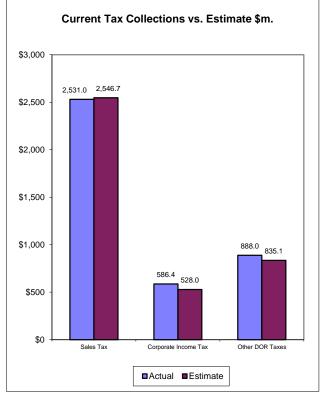
CIT collections of \$586.4m in September 2019 were above the estimate by \$58.4m (11.1%) and over the September 2018 collections by \$113.9m (24.1%). The estimates are based on the August 14, 2019 GR conference (page 4).

#### **DOCUMENTARY STAMP TAX**

Documentary Stamp Tax collections of \$233.3m were greater than the estimate in September 2019 by \$30.3m (14.9%) and above the September 2018 collections by \$26.7m (12.9%). The estimates are based on the August 14, 2019 GR conference (page 5).

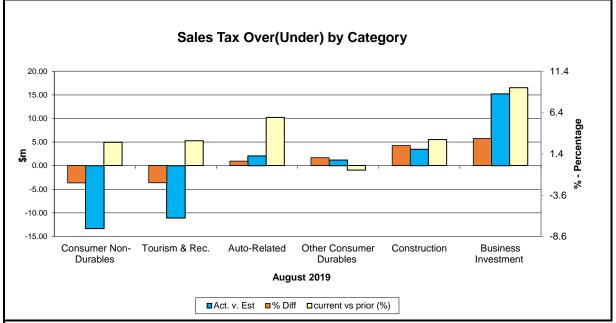
#### SALES TAX ...

... COLLECTIONS IN September 2019 of \$2,530.9m were \$-15.7m (-0.6%) below the estimate. The September 2019 Sales and Use Tax collections were \$143.3m (6%) above the September 2018 Sales and Use Tax collections (see Graph on page 1). The estimates are

based on the August 14, 2019 GR conference.

## Analysis of August collections by category...

Four categories were above the estimates in August 2019, with Business Investment (3.3%) above, Construction (2.4%) above, Other Consumer Durables (0.9%) above, and Auto-Related (0.5%) above. Consumer Non-Durables was (-2.1%) below, and Tourism & Rec. (-2.1%) below. Compared to August 2018, five categories were above the same month collections last year, Business Investment being the strongest at 9.4% above, while Other Consumer Durables was the weakest at (-0.6%).The estimates are based on the August 14, 2019 GR. Note: August 2019 sales tax collections by categories reflect July 2019 activity.

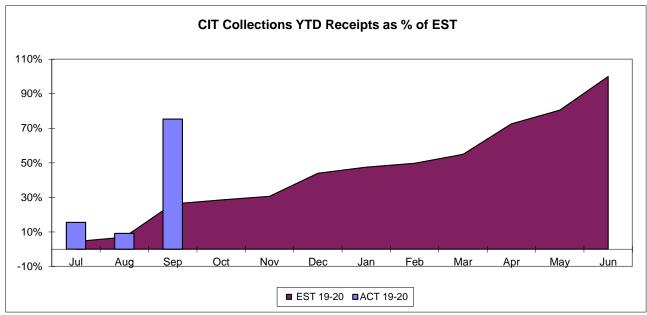


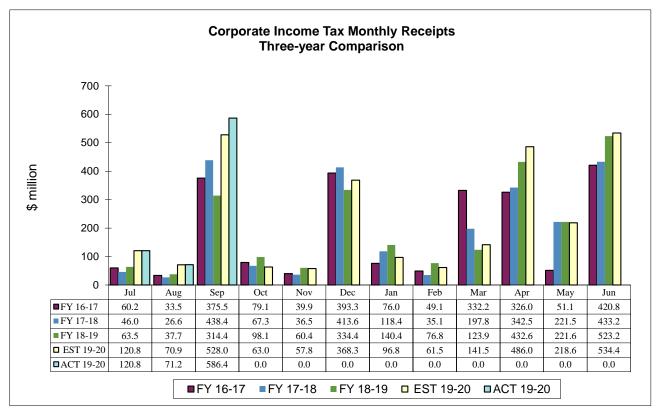

#### CORPORATE INCOME TAX....

... COLLECTIONS of \$586.4m in September 2019 were above the estimate by \$58.4m (11.1%) and over the September 2018 collections by \$113.9m (24.1%). The estimates are based on the August 14, 2019 GR conference (page 4).

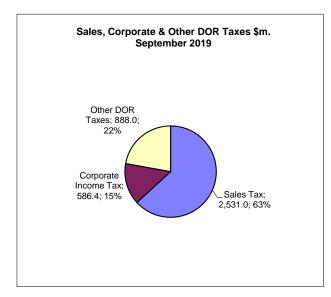


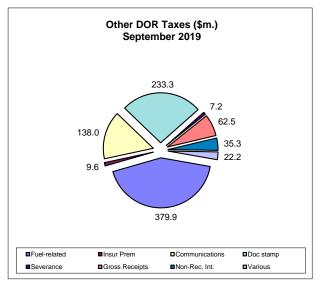


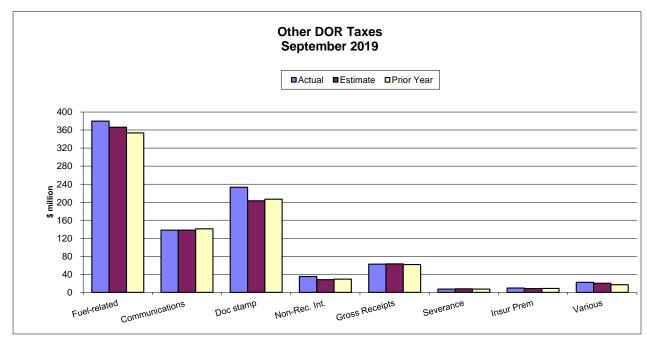
#### OTHER DOR TAXES...

...excluding Sales Tax and Corporate Income Tax, other taxes contributed \$888m to DOR tax collections in September 2019, which were \$52.9m (6.3%) above the estimate. The September 2019 collections were \$62.7m (7.6%) above the same month previous year's collections. The Doc Stamp Collections in September 2019 were \$30.3m (14.9%) above the estimate. Compared to September 2018 collections on Doc Stamp Taxes, the September 2019 collections were \$26.7m (12.9%) above.

The collections of the Communications Services Tax in September were above the estimate by \$0m (0%). Compared to September 2018 collections on Communication Services Tax, the September 2019 collections were \$3m (-2.1%) below. The collections of Insurance Premium Tax in September were above the estimate by \$1.1m (12.9%). Compared to September 2018 collections on Insurance Premium Taxes, the September 2019 collections were \$0.8m (8.9%) above. The collections of Fuel-related Taxes & Fees in September were above the estimate by \$13.5m (3.7%). The non-recurring Intangible Tax collections were \$7.3m (26%) above.
