## SALES AND USE TAX


Sales and Use Tax collections were above the estimate in December by \$6.4m (0.3%) and over the 2013 December collections by \$146.4m (7.7%). The estimates are based on the December 15, 2014 Revenue Estimating Conference (REC) (page 3).

## CORPORATE INCOME TAX

CIT collections of \$393.3m in December were above the estimate by \$56.6m (16.8%) and above the 2013 December collections by \$57.3m (17.1%). The estimates are based on the December 15, 2014 REC conference (page 4).

# DOCUMENTARY STAMP TAX

Documentary Stamp Tax collections were below the estimate by \$1.7m (0.8%) in December and above the 2013 December collections by \$21.2m (12.1%). The estimates are based on the December 15, 2014 REC conference (page 5).






.... Collections of \$393.3m were \$56.6m (16.8%) above the December estimates. The December 2014 CIT collections were \$57.3 million (17.1%) above the December 2013 CIT collections. The estimates are based on the December 15, 2014 REC conference.



## OTHER DOR TAXES...

...excluding Sales Tax and Corporate Income Tax contributed \$757.1m to DOR tax collections in December, which were \$24.9m (3.2%) below the estimates. The December collections were \$38.1m (5.3%) above the same month previous year's collections. Doc Stamps collections were \$1.7m (0.8%) below the estimates. The Doc Stamps collections in December were \$21.2m (12.1%) above the December 2013 collections. The non-recurring Intangible Tax in December was right on the target. Compared to the December 2013's collections, the non-recurring Intangible Tax was 12.9% above. The December collections on Fuel Related Taxes were \$0.8m (0.3%) below the estimates. Compared to December 2013 collections on Fuel Related Taxes, the December 2014 collections were \$9.6m (3.1%) above. The Communications Services Tax collections were \$19.1m (10.3%) below the estimates. The 2.5% Gross Receipt Utility Tax collections in December 2014 were \$1.1m (2.2%) below the estimates, and were 3.2% above the same month's collection in the prior year. Insurance Premium Tax collections were \$1.7m below the estimates in December 2014.





# **HISTORICAL COMPARISON GRAPHS**

Pages 7-16 contain graphs for individual tax sources comparing the current fiscal year's actual and projected collections and collections for the three most recent fiscal years. The upper panel on each page presents monthly collections. The lower panel compares actual and expected collections on a fiscal year basis. In the lower panel, the bars prefaced by 'ACT' depict actual collections through the current month of each respective year. The bar prefaced by 'EST' shows that cumulation of the current year's DOR estimate through the current month. DOR's estimates are derived from estimates produced by the REC in <u>December 2014</u>. These estimates are adjusted to make them compatible with DOR's cash collection figures.
